#### The Promoter

- 10. - 11. Participants will then receive a call from the Promoter's customer service team who will attempt to resolve any issues the Participant has. Should the Participant still wish to return the Promotion Product they will be provided with a unique reference number ("NQ Code") by email. - 12.
