

PROMOTION TERMS & CONDITIONS

Please read these Promotion terms and conditions (“Terms and Conditions”) carefully. Participation in this Promotion will constitute your agreement to comply with these Terms and Conditions. If you do not agree with these Terms and Conditions, please do not participate in this Promotion.

These Terms and Conditions will govern the redemption of your choice between either a Samsung Gear VR (SM-R323) (“**VR**”) or Accessory Kit (ET-KG930BSEGWW for S7, ET-KG935 BSEGWW for S7 edge). All participants during the term of this Promotion agree to be bound by the following terms and conditions:

1. Promotion:
Galaxy S7 or S7 edge plus Gear VR or Accessory Kit (“Promotion”). The promoter of the Promotion is Samsung Electronics South Africa (Proprietary) Limited, Registration number: 1994/003872/07 and/or its agencies (“**Organizer**”).
2. Promotion Period:
 - 2.1. The Promotion will run from 14 November 2016 (00h00) to 28 February 2017 (23h59) (“**the Promotion Period**”).
 - 2.2. The duration of the Promotion may be extended or curtailed at the discretion of the Organizer.
 - 2.3. Promotion is valid while stock lasts.**
 - 2.4. In the event that stock of either the VR or Accessory Kit is depleted, the participant will only be able to redeem the option which is currently available.
3. Who may enter:
 - 3.1. All participants must:
 - 3.1.1. be citizens of the Republic of South Africa and/or a legal resident of the aforesaid country,

- 3.1.2. be currently residing in the Republic of South Africa at the date of the commencement of the Promotion Period,
 - 3.1.3. be a natural person and be at least 18 (eighteen) years old at the date of the commencement of the Promotion Period,
 - 3.1.4. be in the possession of a valid identity document at the time of redemption of the VR or Accessory Kit.
 - 3.2. Participation in this Promotion excludes the Organizer, their directors, members, partners, employees, agents, consultants, any other person who directly or indirectly controls or is controlled by them or any supplier of goods and services in connection with the Promotion and their spouses, life partners, parents, children, siblings, business partners or associates.
4. How to qualify for the Promotion:
 - 4.1. the participant must:
 - 4.1.1. Have purchased a Samsung Galaxy S7 or
 - 4.1.2. Samsung Galaxy S7 Edge (“Device” or “Devices”) in South Africa for either cash or on contract.
 - 4.1.3. Have purchased the Device during the Promotion Period.
 - 4.1.4. Have downloaded the Samsung Rewards application from the Google Play Store on a Samsung Galaxy S7 or Samsung Galaxy S7 Edge and be a registered subscriber of the Samsung Rewards service managed by the Organizer.
 - 4.1.5. Have redeemed the VR or Accessory Kit through the Samsung Rewards application during the Promotion Period.
 - 4.2. No claims for any VR’s or Accessory Kit’s for Devices purchased during the Promotion Period will be accepted or processed after 03 March 2017.
 - 4.3. Proof of purchase may be required as part of the redemption process.
5. Can I qualify more than once for the Promotion:
 - 5.1. The Promotion is limited to a participant making a choice between one VR or Accessory Kit per valid device purchased (unique IMEI), should there be any dispute in this regard, the Organizer shall be sole adjudicator of the dispute and the Organizer’s decision shall be final.

- 6.2. The VR or Accessory Kit is not transferable. No substitution, cash redemption, or assignment of the VR or Accessory Kit is permitted.
- 6.3. The VR or Accessory Kit may differ from that shown on the promotional material with regard to colour and specs and same shall be subject to availability and in the Organizer's sole discretion to select same.

Terms of Delivery:

- 7.1. Delivery of the VR or Accessory Kit will occur within 4 (four) weeks of receipt of confirmation of the participants delivery details that have been supplied by the participant through the Samsung Rewards application.
- 7.2. Should the participant fail to supply valid delivery details upon redemption of the VR or Accessory Kit through the Samsung Rewards application, the VR or Accessory Kit will be forfeited.
- 7.3. Delivery of the VR or Accessory Kit will occur by way of courier and the Organizer does not accept any responsibility for late/non arrivals.
- 7.4. In the event that the participant is unreachable or fails to claim the VR or Accessory Kit after 2 (two) attempts to deliver over a period of 10 (ten) working days, the VR or Accessory Kit shall be forfeited.
- 7.5. The participant shall present a valid identity document at the time of delivery of the VR or Accessory Kit.
- 7.6. Deliveries will only be made within the borders of the Republic of South Africa.
- 7.7. Deliveries will occur from Monday to Friday during regular office hours (08h00 to 17h00) and no deliveries will be made on public holidays or over the weekends.

Limitation of Liability:

- 8.1. To the extent permitted by Consumer Protection Act and any other applicable law:
 - 8.1.1. The participant and/or winner(s) hereby indemnifies the Organizer against any direct, indirect, special, incidental, consequential or punitive damages or loss of any kind regardless of how this was caused, and whether it arose under the law of contract or delict or otherwise, because of the participants entrance to the Promotion.

The onus rests on the participant to constantly check the website for updates to the terms and conditions.
- 9.6. The Organizers reserve the right, at any time, to verify the validity of participants (including a participant's identity, age and place of residence) and to reject any participant who has not agreed to these Terms and Conditions. Errors and omission may be accepted at the Organizer's discretion. Failure by the Organizer to enforce any of its rights at any stage does not constitute a waiver of those rights.

- 9.13. If part or all of any clause of these Terms and Conditions is illegal, invalid or unenforceable:
- 9.13.1. It will be read down to the extent necessary to ensure that it is not illegal, invalid or unenforceable, but if that is not possible;
- 9.13.2. It will be severed from these Terms and Conditions and the remaining provisions of these Terms and Conditions will continue to have full force and effect.
