

HANDRAISER / FULL FORM REGISTER TO WIN TERMS & CONDITIONS

Please read these Competition Terms and Conditions (“Terms and Conditions”) carefully. Participation in this Competition will constitute your agreement to comply with these Terms and Conditions. All participants during the term of this Hand raiser agree to be bound by the following Terms and Conditions:

1. COMPETITION:

- 1.1. Unpacked Hand raiser/Full form register to win (“Competition”).
- 1.2. The promoter is Samsung Electronics West Africa Limited and any appointed agencies (“Organizer”).

2. COMPETITION PERIOD:

- 2.1 The Competition runs from 00:00am on 11th February, 2026 to 11:59pm on 25th February, 2026 (“Competition Period”).
- 2.2 The Organizer may extend or curtail the Competition Period at its discretion.

3. WHO MAY ENTER:

- 3.1 All participants must:
 - a. be citizens of the Federal Republic of Nigeria and/or legal residents of the aforesaid country;
 - b. must be currently residing in Nigeria at the date of the commencement of the Competition;
 - c. must be a natural person and be at least 18 (eighteen) years old at the date of the commencement of the Competition.
- 3.2 Participation in this Competition excludes the Organizer, their directors, members, partners, employees, agents, consultants, any other person who directly or indirectly controls or is controlled by them or any supplier of goods and services in connection with the Competition and their spouses, life partners, parents, children, siblings, business partners or associates.

5.2 Should there be any dispute in this regard, the Organizer shall be sole adjudicator of the dispute and the Organizer's decision shall be final.

7.3 A participant will undergo verification to the satisfaction of the Organizer.

8.1 To the extent permitted by the Federal Competition and Consumer Protection Act of Nigeria and any other applicable law:

a. The participant and/or winner(s) hereby indemnify the Organizer against any direct, indirect, special, incidental, consequential, or punitive damages or loss of any kind regardless of how this was caused, and whether it arose under the law of contract or delict or otherwise, because of the participants' entrance to the Competition.

b. The Organizer excludes all warranties (express or implied), representations, and liabilities (except for death or personal injury caused by negligence or fraud).

9. GENERAL:
