<b>Personal Information</b>	Full name, phone number, email address and residential address.

(" <b>Quiz Question</b> ").  The answer must be submitted by responding to Samsung's Quiz Question post on the SMC Platform. The Prize will be awarded to the first three (3) Eligible Entrants to share the correct answer to the Quiz Question.  Each Eligible Entrant may only enter once.
