  - be one of the forty (40) Eligible Claimants to submit the fully completed Online Claim Form during the Claim Period and receive confirmation in accordance with (2) below, (Online Claim Forms will not be accepted after the end of the Claim Period),

<p><b>Purchase</b></p>	<p>Means payment in full. This can be by cash, card or any other credit program that the Participating Store accepts, where a proof of purchase is provided.</p>
<p><b>Delivery of Gift</b></p>	<ol style="list-style-type: none"> <li>1. Eligible Claimants should allow at least ninety (90) days for delivery of the Gift from the date they receive notification from Samsung that their Eligible Claim is being processed. Samsung will use all reasonable endeavours to deliver the Gift within sixty (60) days from the date notification is received, however this may be subject to delay in some circumstances.</li> <li>2. Gifts will be delivered to mailing address submitted at the time of submitting an Eligible Claim.</li> <li>3. Gifts will be delivered by a courier partner of Samsung's choosing and must be signed for at time of delivery.</li> <li>4. A parcel collection card will be left at the Eligible Entrant's delivery address if no one is present at the time of attempted delivery. The Gift will then be delivered to a local Australia Post Office for your collection.</li> </ol>
