Samsung may, in its absolute discretion, invalidate any claims if the claimant fails to provide the further requested information within fourteen (14) days of the notification email from Samsung.</p>
<p><b>Purchase</b></p>	<p>Means payment in full. This can be by cash, card or any other credit program that the Participating Store accepts, where a proof of purchase is provided.</p>
<p><b>Delivery of Gift</b></p>	<ol style="list-style-type: none"> <li>1. Eligible Claimants should allow at least ninety (90) days for delivery of the Gift from the date they receive notification from Samsung that their Eligible Claim is being processed. Samsung will use all reasonable endeavours to deliver the Gift within sixty (60) days from the date notification is received, however this may be subject to delay in some circumstances.</li> <li>2. Gifts will be delivered to mailing address submitted at the time of submitting an Eligible Claim.</li> <li>3. Gifts will be delivered by a courier partner of Samsung's choosing and must be signed for at time of delivery.</li> <li>4. A parcel collection card will be left at the Eligible Entrant's delivery address if no one is present at the time of attempted delivery. The Gift will then be delivered to a local Australia Post Office for your collection.</li> </ol>
<p><b>General</b></p>	<ol style="list-style-type: none"> <li>1. Participation in this Promotion is deemed acceptance of these T&amp;Cs.</li> <li>2. A claimant is not an Eligible Claimant and is not entitled to a Gift if that claimant returns the Participating Product for a refund or exchange. If the CCA or any other legislation implies a condition, warranty or term into the Terms and Conditions or provides statutory guarantees in connection with these Terms and Conditions, in respect of goods and services supplied (if any), Samsung's liability for breach of such a condition, warranty, other term or guarantee is limited to (at Samsung's election), to the extent it is able to do so: (a) in the case of supply of goods, Samsung doing any one or more of the following: (i) replacing the goods or supplying equivalent goods; (ii) repairing the goods; (iii) paying the cost of replacing the goods or of acquiring equivalent goods; and/or (iv) paying the cost of having the goods repaired; or (b) in the case of supply of services, Samsung doing either or both of the following: (i) supplying the services again; and/or (ii) paying the cost of having the services supplied again.</p> <p>18. These Terms and Conditions are governed by the laws of New South Wales. Claimants submit to the non-exclusive jurisdiction of the courts of New South Wales.</p>
