

## **Terms & Conditions**

### Samsung – India With Galaxy Photography Contest

Samsung Galaxy smartphone users who have attained the age of 18 years or above, and are resident of India, except for residents of state of Tamil Nadu , or having valid Proof of Address/Proof of Identity issued by state of Tamil Nadu or such other state(s) whereas Offer is prohibited by law), can participate in the Contest as per the terms hereof.

Mandatory checks at submission: Image must be captured using a Galaxy S Series device (validated via EXIF metadata).

Entry must be submitted within the contest window as mentioned below

Violence or discriminatory content

Material that harms religious or cultural sentiments

Third-party intellectual property
