WHAT INFORMATION DO WE COLLECT?

Through Solve for Tomorrow, we obtain and maintain information about you in various ways.

Information You Provide Directly

- Personal Information such as Name, age, contact details (email, phone number) school/College details, city/state of residence and other identifiers required for eligibility verification.
- Other personal information of selected participants such as ID Proofs for managing travel, boarding & logistics to key events of the competition; and Bank Details & PAN ID details for transferring grants as applicable in each phase of the competition. In case of any selected participants below 18 Years of Age, the Bank Details & PAN ID of guardians / parents will be obtained.
- Project- Related Data: Submission details, team information, project descriptions and any materials uploaded as a part of the program.
- Usage Data: Website interactions, IP Address and browsing behavior when accessing the Solve for Tomorrow website.
- Media and Publicity Information: Photos, videos, and testimonials provided by you or captured during program events, which may be used for promotional purposes with your consent.

HOW DO WE USE YOUR INFORMATION?

We use the information collected for the following purposes:

- To process and evaluate applications for the Competition.
- To communicate updates, announcements, and necessary information regarding the Competition.
- To promote Competition through Samsung's official platforms, social media, and media partnerships
- To ensure compliance with legal and regulatory requirements.
- To analyze participation trends and improve future editions of the Competition.
- protect against, identify and prevent fraud and other criminal activity, claims and other liabilities;

- comply with and enforce applicable legal requirements, relevant industry standards and our policies, including this Privacy Notice and the Privacy Policy.

WHO DO WE SHARE YOUR INFORMATION WITH?

We will disclose your information internally within our business and to the following entities, but only for the purposes described above.

- Program Partners &Affiliates: Organizations, mentors, judges, and institutions involved in executing and supporting the program.
- Service Providers and Vendors: Third party agencies that assist with program management.
- Marketing and Media Agencies: We may share limited information for promotional activities, including press releases, social media and event coverage.
- Event Organizers: If you participate in Solve for Tomorrow Innovation Bootcamp, Grand Finale or other related events, basic details may be shared for logistical arrangements.
- Business partners: partners who we work together with to provide you with Competition, such as Implementation partner for arranging online training and mentoring sessions. These business partners control and manage your personal information;
- Other parties when required by law or as necessary to protect Solve for Tomorrow: for example, it may be necessary by law, legal process, or court order from governmental authorities to disclose your information. They may also seek your information from us for the purposes of law enforcement, national security, anti-terrorism, or other issues that are related to public security;
