FOR SAKE OF CLARITY, IT IS CLARIFIED THAT THE COMPETITION SHALL BE IMPLEMENTED END TO END AND INDEPENDENTLY BY OUR IMPLEMENTATION PARTNER VIZ. FOUNDATION FOR INNOVATION AND TECHNOLOGY TRANSFER, INDIAN INSTITUTE OF TECHNOLOGY DELHI (IIT-D). ALL QUERIES RELATED TO THE COMPETITION SHALL BE ADDRESSED BY FOUNDATION FOR INNOVATION AND TECHNOLOGY TRANSFER, INDIAN INSTITUTE OF TECHNOLOGY DELHI (IIT-D).

#### Entry into the Competition signifies acceptance of these Terms and Conditions.

The Competition is divided under two tracks – School Track (solving for India) and Youth Track (solving for the world).

The School Track is open for the age group 14-17 years under the Theme "Community and Inclusion" which aims at uplifting underprivileged groups, improving accessibility to health and social inclusion for all.

The Youth Track is open for the age of 18-22 years under the Theme "Environment and Sustainability" which aims to reduce carbon footprint, protecting environment and promoting sustainability.

The Competition for each track is divided into four phases with a selection process at each phase, so that only those Applicants who pass a phase can participate in a subsequent phase.

# 2. ELIGIBILITY

- 2.1 The Competition is open to Indian nationals aged 14 to 17 years for the School Track and Indian Nationals aged 18-22 years for the Youth Track on the final day of the application period (i.e 31/05/2024). Registration of Applicant between the age group of 14 to 17 can be done by the parent/guardian on behalf of the Applicant. Only individuals meeting all the required terms and conditions can participate and not entities like partnership firms, companies, schools, colleges etc.
- 2.2 Teams with members between 14-17 years of age can only apply in the "School Track" under the theme of "Community & Inclusion" and teams with members between 18-22 years of age can only apply in the "Youth Track" under the theme of "Environment & Sustainability".
- 2.3 Applicant does not need to pay any amount for application.
- 2.4 Employees or agents of Samsung or its implementation agencies including Implementation Partner, or any of its group companies or their immediate families or households or anyone professionally connected to the Competition are not eligible to participate.
- 2.5 Ideas that are currently receiving funding or support, or which have previously received funding/support of INR 5,00,000 (Indian Rupees Five Lakh only) or above in total (including series of funding) in any manner whatsoever are not eligible to enter.

- 2.6 The Competition is open to single individual or teams comprising of up to five (5) individuals in both tracks.
- 2.7 The Team Leader (himself/herself/or through the legal guardian, in case of being a minor) shall make an entry on behalf of the Team. Each of the Team Member (including the Team Leader) jointly and severally accept, that the entry is made on their behalf subject to these terms.
- 2.8 Each Applicant may only be part of one entry, either on their own or as part of a single team. In other words, an individual cannot participate as more than one Applicant or as members of more than one Team.
- 2.9 While submitting the Application, for determination of the location, the State needs to be mandatorily selected. Upon selection of State, the appropriate Region shall be automatically identified by the system.

For the purpose of determination of Regions, in case of School Track, the physical location of the School(s) to which the applicants are enrolled shall be considered and accordingly needs to be filled by the Applicant/Team Leader. In case of an applicant/Team Leader not being enrolled in any school, then the permanent address of the applicant/Team Leader will be considered and accordingly needs to be filled by the Applicant and accordingly needs to be filled by the Applicant/Team Leader will be considered and accordingly needs to be filled by the Applicant/Team Leader. In case of a Team comprising members from different Regions, the Region shall be determined basis the school of the Team Leader or the permanent address, in case if the Team Leader is not enrolled with any school.

For the purpose of determination of Regions, in case of Youth Track, the physical location of the College/Institute to which the applicants are enrolled shall be considered and accordingly needs to be filled by the Applicant/Team Leader. In case of an applicant/individual not being enrolled in any college/institute, then the permanent address of the applicant/Team Leader will be considered and accordingly needs to be filled by the Applicant. In case of a Team comprising members from different Regions, the Region shall be determined basis the College/Institute of the Team Leader or the permanent address, in case if the Team Leader is not enrolled with any College/Institute.

Supporting documents for address proof, school/college ID card etc needs to be mandatorily submitted.

Samsung's decision in relation to determination of Region shall be final and binding.

- 2.10 Each Applicant/Team shall submit one (1) Idea only.
- 2.11 Applicants must create their own work, and not copy text, idea, images, audio, or video recordings from third parties. It has to be an original work and not reproduction of work created by others.
- 2.12 Participants/Teams that are shortlisted must be available to attend regional pitch event/rounds (which may be conducted online or offline), all workshops, mentoring sessions and the Final Pitch Event as directed by the Implementation Partner, in order to be eligible to continue participating in the Competition. Samsung, at its sole discretion, reserves the right to disqualify any such Participant who fails to attend any such Pitch events, workshops, mentoring sessions, final pitch event or other events as directed by Implementation Partner.

- 2.13 Samsung and its implementation partner have the right to disqualify Teams in case of non-attendance during workshops, online classes, or pitch events. In the case of disqualification, the next eligible team as per the phase of the competition with the maximum marks may, at the sole discretion of Samsung, be given an offer to join the Competition.
- 2.14 Each Applicant will act in good faith, cooperate with any requests from Samsung or its Implementation Partner, in a timely manner and not act in a manner, which may adversely affect Samsung's reputation, or adversely affect the health, safety or wellbeing of Samsung or implementation partner's staff or that of any other Applicant. Samsung reserves the right to disqualify any Applicant who breaches/does not meet the provisions or requirements of these Terms and Conditions.

There may be an addition of dates for any related workshops or media shoots that will be notified to the teams and their guardians in prior.

Exact dates and curriculum of workshops, online classes and the pitch event will be confirmed closer to the time, and the Implementation Partner will work with Phase 2 Teams to secure convenient dates. Attendance on the agreed dates will be mandatory in order to progress with the Competition. Samsung reserves the right to disqualify any Participant for failure to attend the sessions and no claims whatsoever shall be entertained in this regard.

# 4. "PHASE 1" - APPLICATION WINDOW

- 4.1. Applicants must submit their Entry by duly and completely filing the Application Form on <u>www.samsung.com/in/solvefortomorrow/</u> by 17:00 hours (IST) on 31 May 2024 (the "Application Deadline") under the School Track or Youth Track (as applicable).
- 4.2 The application for teams under the "School Track" with theme "Community & Inclusion" is separate from application for teams under "Youth Track" with theme "Environment & Sustainability". Illegible applications with teams that do not match age criteria for the two tracks will be disqualified. Applications by any Team without submitting supporting documents, incomplete applications etc will be disqualified.
- 4.3 Each Applicant can submit a maximum of one (1) entry.

# a. School Track

Applications in the "School Track" between 14-17 years will apply in the theme:

## "Community & Inclusion"

The Entry must consist of:

- the fully completed online application form, with answers to all questions, and
- a self-attested copy of any official document of identity of each member of the Team.
- Entry must consist of School name and city for the Applicants applying under School Track. If applicant(s) not enrolled in any educational institution, permanent address to be used, it shall be mandatory to select the name of the State while submitting the Application. Once the State has been selected by the Applicant and Application submitted, there shall not be any change to the same;
- For the purpose of Regional shortlists, the Application shall be considered basis the State selected at the time of filling the Application. In case of members of the Team from different regions, then the physical location of School of the Team Leader shall be considered (mandatory to use school name and address with city and state if presently enrolled by Team Leader. If not enrolled, then permanent address of Team Leader to be considered)
- Other team members who do not fall in same zone, shall not raise any concern in this matter at any point of time and participation in the Competition shall be deemed acceptance of all terms and conditions.
- Any other topics which are not under the applicable themes will not be considered for the competition

#### b. Youth Track

Applications in the "Youth Track" between 18-22 years will apply in the theme:

### "Environment & Sustainability"

The Entry must consist of:

- the fully completed online application form, with answers to all questions, and
- a self-attested copy of any official document of identity of each member of the Team.
- Entry must consist of College/institute name and state for the applicants applying under youth track. If applicant(s) not enrolled in any educational institutional, permanent address to be used, state name remains mandatory in either case.
- For the purpose of Regional Shortlists, the Application shall be considered basis the State selected at the time of filling the Application. In case of members of the Team from different regions, then the physical location of College of the Team Leader shall be considered (mandatory to use the college name and address with city and state if presently enrolled by Team Leader. If not enrolled, then permanent address of Team Leader to be considered).
- Other team members who do not fall in same zone, shall not raise any concern in this matter at any point of time and participation in the Competition shall be deemed acceptance of all terms and conditions.
- Any other topics which are not under the applicable themes will not be considered for the competition.
- 4.4 Entries in the competition will be divided based on 5 (five) zones/Regions as classified by Samsung: North, South, East, West and North-east.

North Region/Zone: Ladakh, Jammu & Kashmir, Delhi, Himachal Pradesh, Punjab, Chandigarh, Haryana, Uttar Pradesh, Uttarakhand

East Region/Zone: Sikkim, Bihar, Odisha, Jharkhand, West Bengal, Chhattisgarh

West Region/Zone: Gujarat, Goa, Maharashtra, Dadra & Nagar Haveli, Daman & Diu, Madhya Pradesh, Rajasthan

**South Region/Zone:** Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu, Andamans & Nicobar, Puducherry, Lakshadweep

North-East Region/Zone: Assam, Nagaland, Meghalaya, Manipur, Mizoram, Tripura and Arunachal Pradesh.

Basis the selection of State while filing the Application by the Applicant/Team Leader, the Region/zone shall be automatically identified basis above classification.

## 5. "PHASE 2"- EVALUATION AND REGIONAL SHORTLISTS

5.1 Entries for both tracks will be reviewed and judged by a panel of reviewers of FITT, IIT-Delhi. The Entries which do not meet the requisite Eligibility Criteria shall stand rejected in the first place. The panel of judges shall review the Entries to determine the fifty (50) entries from the School Track (with 10 entries selected from each Region) and fifty (50) entries from the Youth track (with 10 entries selected from each Region)

which, in the panel of reviewers' view, best meet the Selection Criteria for Phase 2-Part I. The panel of judges' decision is final.

- 5.2 The 10 (ten) Teams selected from each Region for School Track (comprising a total selected fifty (50) Teams from School Track) and the 10 (Ten) Teams selected from each Region for the Youth Track (comprising the total selected fifty (50) Teams from the Youth Track) whose Entries have the highest scores will be notified by email and shall proceed further in the Competition.
- 5.3 The selection criteria for determining the top 50 winning Entries (with 10 entries selected from each Region) in first phase of Phase 2 of School Track and Youth Track includes the following criteria ("**Selection Criteria for Phase 2- Part I**"):

Ideas submitted on School Track and Youth Track by applicants will be judged on:

• Best use of technology (app, product or service) to address the track-specific competition theme

- Consideration of the needs of the intended target audience;
- Creativity and originality of the Idea;
- Feasibility of the solution with current technology and resources considered;
- Potential for the idea to beneficially impact society and/or the environment;
- Potential to reach its intended target audience.
- 5.4 Only those fifty (50) Teams from School Track (comprising of 10 Teams selected from each Region) and the fifty (50) Teams from the Youth Track (comprising of 10 Teams selected from each Region) who were successful and notified in accordance with clause 5.3 above can participate further.
- 5.5 Post selection of Top 50 Teams in School and Youth track (with top 10 Teams from each Region), in this Phase 2, further screening shall be done and Regional Pitch events/rounds shall be conducted wherein the Top 10 shortlisted teams of each Track in each Region will participate in their respective online regional pitch events/ rounds.

Each idea during the Online regional pitch event/rounds will be reviewed and judged by a panel of judges comprised of employees or agents of Samsung and/or key Partners of the Solve for Tomorrow program as identified by Samsung at its sole discretion. The full name of the judges shall be made available at www.samsung.com/in/solvefortomorrow. The panel of judges' decision is final.

Basis the Regional Pitch events/Rounds, from each Track, Top 2 (two) teams to be selected from each Region by a jury during the online pitch events/ rounds, resulting into total Top 10 (ten) teams from each Track and the same will be announced as:

- Total Top 10 (ten) teams in School Track (comprising of 2 (two) Teams selected from each Region)
- Total Top 10 (ten) teams in Youth Track (comprising of 2 (two) Teams selected from each Region)

These Top 10 (ten) Teams from School Track and Top 10 (ten) Teams from Youth Track shall proceed towards Phase 3 of the Competition.

5.6 Teams who do not enter the online regional pitch event/ rounds or do not participate will be disqualified and will not be permitted to enter the next round.

In case any Team(s) backs out of the Competition, the next eligible regional team may be considered for top 50 (fifty) as per criteria defined by Samsung so on and so forth to complete the selection process in the relevant School Track and Youth Track or Samsung may take such other actions as it may deem desirable including but not limited reducing the number of selected teams etc. In the event of any back out of any selected Participant for any reason whatsoever, Samsung at its sole discretion may be authorised to seek return of any prizes given earlier to such Participant and the Participant agrees to return within such timelines as intimated by Samsung.

- 5.7 The top 10 (ten) Teams from School Track (comprising of 2 (two) teams from each Region) and the top 10 (ten) Teams from Youth Track (comprising of 2 (two) Teams from each Region) whose Pitch and Developed Idea have the highest scores basis the selection criteria identified in Clause 5.8 below will be notified by Samsung by email and will proceed to the Phase 3 of the Competition of School Track and Youth Track respectively.
- 5.8 Selection criteria for selection of top 10 (ten) Teams per Track (comprising of 2 (two) teams from each Region) as part of Phase 2 of School Track and Youth Track includes the following criteria ("**Selection Criteria for Phase 2-Part 2**"):

Ideas will be judged on:

• Best use of technology (app, product or service) to address the track-specific competition theme;

• Clear development of the idea since its original submission at Phase 1;

• Demonstrable use of research and/or testing to understand the needs of the intended target audience;

• Creativity and originality of the Idea;

• Feasibility of the solution with current technology, resources, laws and regulations considered;

- Potential for the Idea to beneficially impact society and/or the environment;
- Potential to reach its intended target audience;
- Demonstration of design thinking;
- Quality of the presentation of the Idea

In any Team(s) backs out of the competition, the next eligible team may be considered for top 10 (ten) as per criteria defined by Samsung for School Track or Youth Track (as applicable) so on and so forth to complete the selection process or Samsung or its implementation partner may take such other decision as it may deem fit including but not limited to reducing the total number of selected teams etc.

#### 6. "PHASE 3" – SEMI-FINALISTS

- 6.1 Only those 10 (ten) Teams from School and Youth Track respectively (comprising of 2 (two) teams from each Region) who were successful and notified in accordance with Clause 5.7 above can participate in Phase 3.
- 6.2 In Phase 3, Teams must further develop their Idea to a more complex concept based on a detailed feedback from Samsung mentors, FITT mentors and such other mentors including mentors nominated by government entities who may collaborate for this Program.
- 6.3 The Top 10 (ten) teams in School Track (comprising of 2 (two) teams from each Region) and top 10 (ten) teams in Youth Track (comprising of 2 (two) teams from each Region) may also receive expert guidance from mentors/experts nominated by government entities who may collaborate for the Program as part of the Competition.
- 6.4 In this phase, Teams will attend "Innovation Walk" at Samsung offices with tentative dates defined in clause 3. At the end of the "Innovation Walk", Teams will pitch their refined idea to jury at IIT-Delhi Pitch Event. Teams who fail to attend the workshops or pitch event will be disqualified from the competition.
- 6.5 Each pitch will be reviewed and judged by a panel of judges comprised of employees or agents of Samsung and/or key Partners of the Solve for Tomorrow program as identified by Samsung at its sole discretion. The panel of judges shall review the Entries to determine the top 5 (five) Teams from School Track and top 5 (five) from Youth track which, in the panel of judges' view, best meet the Selection Criteria Phase 3 as set forth in Clause 6.8 below. The panel of judges' decision is final.
- 6.6 Samsung will also announce the "**Social Media Champion**" winner during this phase. The Social Media Champion Award winner will be based on certain criteria on engagement and reach of social media posts of the participating team.
  - a. Quantity Consistently high volume of posts
  - b. Quality Engaging, informative content
  - c. Platform Variety Use of diverse social media platforms
  - d. Engagement Significant audience interaction
  - e. Consistency Regular posting throughout the competition
  - f. Positive Representation Professional representation of the event
- 6.7 The top 10 (ten) Teams (with 5 (five) teams from School Track and 5 (five) teams from Youth Track) whose Developed Idea have the highest scores basis the selection criteria identified in Clause 6.8 below will be notified by Samsung by email and will proceed to the Phase 4 of the Competition.
- 6.8 Selection criteria for Phase 3 of School Track and Youth Track includes the following criteria ("**Selection Criteria for Phase 3**"):

Ideas will be judged on:

• Best use of technology (app, product or service) to address the track-specific competition theme;

• Clear development of the idea since its original submission at Phase 1;

• Demonstrable use of research and/or testing to understand the needs of the intended target audience;

• Creativity and originality of the Idea;

• Feasibility of the solution with current technology, resources, laws and regulations considered;

- Potential for the Idea to beneficially impact society and/or the environment;
- Potential to reach its intended target audience;
- Demonstration of design thinking;
- Quality of the presentation of the Idea

If any team(s) backs out of the competition, Samsung at its sole discretion may consider the next eligible team for top 5 (five) from School Track or Youth Track as per criteria defined by Samsung so on and so forth to complete the selection process. In the event of any back out of any Participant for any reason whatsoever, Samsung at its sole discretion may be authorised to seek return of any prizes given earlier to such Participant and the Participant agrees to return within such timelines as intimated by Samsung.

## 7. PHASE 4 – FINAL PITCH AND SELECTION OF FINALISTS

7.1 Only those five (5) (five) Teams selected from School Track who were successful and notified in accordance with clause 6.5 above can participate in the Finale Pitch Event for School Track.

Only those five (5) Teams selected from Youth Track who were successful and notified in accordance with clause 6.5 above can participate in the Finale Pitch Event for Youth Track.

- 7.2 Each Finalist of School Track and Youth Track will supplement their developed Idea with a live presentation at the Final Event. The presentation will take place in front of representatives from Samsung and/or such other representatives/experts as may be nominated by Samsung, its Implementation Partner and any government entity collaborating with the Program etc.
- 7.3 If the Finalists plan to support their presentation with multimedia, this content must be sent by email to the email address provided by final presentation submission Deadline.
- 7.4Each developed idea as supplemented by its presentation will be assessed by a panel of judges comprised of employees or agents of Samsung or and/or such other members as identified by Samsung at its sole discretion. Full name of judges shall be made available the Solve for Tomorrow website on at www.samsung.com/India/solvefortomorrow/. The panel of judges shall review the Entries to determine one (1) winning idea in the School Track and one (1) winning idea in the Youth Track which, in the panel of judges' view, best meet the Selection Criteria - Phase 4. The panel of judges' decision is final.
- 7.5 Samsung may also announce the "**Goodwill Award**" for 1 (one) team in School Track and 1 (one) team in Youth Track respectively at the Grand Finale. The Goodwill

Award will be selected (from amongst the top 5 (five) Teams who are participating in the Finale Pitch Event for School Track and Youth Track respectively) by Samsung basis the views/feedback/polling of audience attending the grand finale event, or maybe through an online mechanism, or by alumni of the earlier editions or any other mode as determined by Samsung. This award will be given at the sole discretion of Samsung and applicable taxes will apply which shall be borne by the winner of such award.

- 7.6 The final results will be announced at the pitch event which may be an event livestreamed on TV and other digital platforms.
- 7.7 Selection criteria for Phase 4 of school track and youth track includes the following criteria ("**Selection Criteria for Phase 4**" or "**Winning Criteria Phase 4**"):

Ideas will be judged on:

• Best use of technology (app, product or service) to address the track-specific competition theme;

• Quality of detail and clarity within the final plan as showcased at the Pitch Event;

• Clear development and refinement of idea since Phase 2, including creation of prototype and testing with intended target audience;

• Creativity and originality of the idea;

• Feasibility of the solution with current technology, resources, laws and regulations considered;

- Potential for the idea to beneficially impact society and/or the environment;
- Potential to reach its intended target audience;
- Demonstration of design thinking.

#### 8. GRANTS

8.1 **GRANTS TO TEAMS WHICH ARE SHORTLISTED UNDER PHASE 2 PART 2**-The selected ten (10) Teams shortlisted by Selection Criteria for Phase 2 – Part 2 in School Track and the selected ten (10) Teams shortlisted by Selection Criteria for Phase 2- Part 2 in Youth Track will receive a Grant of INR 20,000 (Indian Rupees Twenty Thousand only) per Team (subject to applicable taxes) to develop their prototype.

The Grant will be used to the Teams to work on their prototype which they will present during their Pitch session at the IIT-Delhi Pitch event in Phase 3.

In addition to the grant, each member of the Top 10 Teams in School Track and Top 10 teams in Youth Track will receive Samsung products as advised by Samsung. The Samsung products may/will differ for School Track and Youth Track.

8.2 **GRANTS TO TEAMS WHICH ARE SHORTLISTED UNDER PHASE 3** - The selected 5 (five) Teams in Phase 3 shortlisted by Selection Criteria for Phase 3 in School Track and selected 5 (five) Teams in Phase 3 shortlisted by Selection Criteria for Phase 3 in Youth Track will receive a grant of INR 1,00,000 (Indian Rupees One Lakh only) per Team (subject to applicable taxes) for finalising/enhancing their prototype.

The grant will be used by the Team to fine-tune their prototype which they will then showcase at the Grand Finale. In addition, member of Top 5 (five) teams of School Track and Youth Track respectively will receive Samsung products as advised by Samsung.

The Samsung products may/will differ for School Track and Youth Track.

## 8.3 GRANTS TO FINAL WINNER TEAM SELECTED UNDER PHASE 4 -SCHOOL TRACK

The final 1 (one) winning team in School Track will be the highest scoring finalist as selected by Selection Criteria for Phase 4 for School Track. The grant will be capped at INR 25, 00, 000 (Indian Rupees Twenty Five Lakh only) subject to applicable taxes. The grant will be used for prototype enhancement and therefore disbursed by the implementation partner through phased milestones.

In addition, the school(s) of the winning team will receive Samsung products as advised by Samsung. The Samsung products may/will differ for School Track and Youth Track. In case of non-attainment of any phased milestones by the winner, Samsung or the Implementation Partner shall be entitled to take such action as it may deem fit.

# 8.4 GRANTS TO FINAL WINNER TEAM SELECTED UNDER PHASE 4 -YOUTH TRACK

The final 1 (one) winning team in Youth Track will be the highest scoring finalist as selected by Selection Criteria for Phase 4 for the Youth Track. The grant will be capped at INR 50, 00, 000 (Indian Rupees Fifty Lakh only) subject to applicable taxes. The grant will be used for "incubation" and therefore disbursed by the implementation partner through phased milestones.

In addition, the college(s) of the winning team will receive Samsung products as advised by Samsung. The Samsung products may/will differ for School Track and Youth Track. In case of non-attainment of any phased milestones by the winner, Samsung or the Implementation Partner shall be entitled to take such action as it may deem fit.

- 8.5 **GOODWILL AWARD**: The winning team for the "Goodwill Award" will be the highest scoring finalist based on audience polling during/before/after the event online or offline under School Track and Youth Track. The "Goodwill Award" winner under each of School Track and Youth Track will receive a grant of INR 1, 00, 000 (Indian Rupees One Lakh only) each subject to applicable taxes.
- 8.6 **SOCIAL MEDIA CHAMPION AWARD** The "Social Media Champion" will be the highest scoring team from the top 10 (ten) teams based on criteria on social engagement under School Track and Youth Track as defined by Samsung under Clause 6.6 of these Terms. The "Social Media Champion" winner will receive a grant of INR 50,000 (Indian Rupees Fifty Thousand only) under School Track and Youth Track respectively subject to applicable taxes.
- 8.7 Samsung and its implementation partners hold the right to retrieve Samsung products given to selected teams / individuals if any Participant or any of its team members decide to leave the programme in the middle or are unable to attend workshops or trainings and no claims in this regard shall be raised by Participants

> Each Applicant understands that Samsung and FITT Delhi, their affiliated companies, relevant entities collaborating for the Program may use their email id/phone number for contacting in case of any future similar competitions to be held by Samsung and/or its Implementation Partner.
