

Terms & Conditions – Multi-Buy Offer on Galaxy Book5 Series: Buds3 PRO

 - I. In case the Customer purchases the Device on Online Outlet/ Online Portal, Customer will have to make a full payment of the amount as declared on the respective Online Outlet/ Online Portal
