

Samsung EPP Referral Program 2026

Terms and Conditions

1. Introduction

- 1.1 The Samsung EPP Referral Program 2026 ("**Promotion**") is organized by Samsung Malaysia Electronics (SME) Sdn Bhd [Company No. 200301026766(629186-D)] ("**Samsung**").
- 1.2 The sales transaction in the Promotion is between the Participating Store (as defined below) and Customer. Samsung only provides the recommended retail price ("**RRP**") and/or redemption guidance on this site.
- 1.3 Customer agrees to comply with all the above when accessing or using this site. The scope of these Terms and Conditions is limited to Samsung's role of hosting this site and organizing this Promotion only.
- 1.4 The Promotion is on first come first served basis and while stocks last.

2. Promotion Period

- 2.1 The Promotion will run during the promotion period set out below or while promotional stocks last, whichever is earlier ("**Promotion Period**").

- 3.1 The Promotion is open to all Malaysian Citizens and residents of Malaysia of 18 years old and above (as of 01 January 2026) with Malaysia Identity Card/ valid passport; except Samsung's employees (and their immediate families), its related agencies, retailers and dealers.

Log in the selected Samsung External EPP Online Stores account</p> <p>If you do not have a Samsung External EPP Online Stores Account, you will need to sign up for one.</p> <p>Your Samsung External EPP Online Stores Account must link to your company email or Edu email.</p> <p>2. After logging in, go to the Home Page to locate information about the Referral Program.</p> <p>3. Share your unique referral link with your referee/invitee until a successful referral is completed.</p> <p>4. Once validated, your discount voucher will be automatically issued.</p>
Step 2:	<p>1. Add a minimum of one (1) Samsung product to your cart</p> <p>2. On the cart page, enter a valid referral voucher code in the voucher code box and select "Redeem".</p> <p>3. The discount will be reflected in the total bill.</p> <p>Note: All purchases must be in a single receipt/transaction.</p>
Step 3:	Checkout and make payment accordingly.

5.1.3 How to enjoy Samsung EPP Referral Program 2026 for Referee/Invitee:

Step 1:	<p>1. Receive the referral link from referrer/inviter.</p> <p>2. Sign up for the selected Samsung External EPP Online Stores account. If you do not have a Samsung Account, you will need to sign up for one. Your Samsung account must link with your company email or Edu email.</p>

Step 2:	1. Log into the selected Samsung External EPP Online Stores Account. 2. Go to My Voucher after you have successfully logged in to your Samsung External EPP Online Stores Account. 3. Discount voucher will be automatically issued within the selected Samsung External EPP Online Stores site.
Step 3:	1. Add a minimum of one (1) Samsung product to cart 2. In the cart page, enter a valid referral voucher code in the voucher code box and select "Redeem". 3. The discount will be reflected in the total bill. Note: All purchases must be in a single receipt/transaction.
Step 4:	Checkout and make payment accordingly

- i. Referral voucher codes for both the referrer and the invitee can be viewed in the My Voucher section (Samsung External EPP Online Stores' Home > My voucher) and are valid for one month from issuance or any other period determined by Samsung. Samsung shall not be responsible for any disadvantages resulting from non-use within this period.
- ii. Each voucher code is valid for one registration only, and in the case of multiple referral links being clicked, only the referral voucher code from the final link holds validity.
- iii. Invitee must be a completely new user to EPP to be eligible for this voucher.
- iv. Should the referee/invitee join the selected Samsung External EPP Online Stores account without using the referral code link, inputting a separate code post-registration is not feasible.
- v. If the referrer/inviter withdraws from the selected Samsung External EPP Online Stores account membership after sharing the referral link, the previously generated link becomes void.
- vi. Both the referrer and the invitee will receive a 10% off discount (Capped at RM200).

6. Payment

- 6.1 Customer acknowledges, understands and agrees that all transactions are between Customer and Dealer only. Samsung only acts as the coordinating party and is not involved or a party of any monetary/sale and purchase of this order transaction.
- 6.2 Customer is not allowed to cancel the order, change the selected device colour or model, or the selected outlet once Customer has successfully completed and confirmed the payment transaction.
- 6.3 Customer shall pay the full amount for the order directly to Dealer only.

7. Delivery

- 7.1 The fulfilment and delivery of the product is handled by Samsung SDS Malaysia Sdn Bhd ("SDS").
- 7.2 SDS reserves the right to appoint a third (3rd) party vendor or service provider to handle the fulfilment or making available of the product and delivery of the product to you. By providing your personal information including name, delivery address, contact numbers, email address and other information to SDS, SDS can use and/or disclose to such third (3rd) party vendor or service provider for the purposes of delivery service.
- 7.3 To accept the item, the Customer or the authorised representative or the recipient is required to present identification, i.e. NRIC or Passport to the delivery personnel, failing which the delivery personnel have the right to refuse delivery and will return the product to SDS as "unclaimed".
- 7.4 The proof of delivery of product must be in the form of written acknowledgement of receipt of the product by the Customer, the authorised representative or the recipient. If the delivery address is an office address, an acknowledgement by any office staff will be treated as good acknowledgement of the item.
- 7.5 The time for delivery of the product is between the Customer and SDS. Samsung shall not be liable for any delay in delivery of the product howsoever caused.

8. Customer's Covenants

- 8.1 In connection to this Promotion, Customer will not use this site:
 - 8.1.1 To submit fraudulent order, false, inaccurate, misleading, defamatory, or libelous information;
 - 8.1.2 To distribute viruses or any other technologies that may harm Samsung, or the interests or property of other users;
 - 8.1.3 To export the unit purchased except in compliance with the export control laws of relevant jurisdictions and in accordance with posted rules and restrictions.
