

## 2022 Feel The Passion Hear The Roar

### Terms and Conditions

#### 1. Introduction

- 1.1 The 2022 Feel The Passion Hear The Roar ("**Promotion**") is organized by Samsung Malaysia Electronics (SME) Sdn Bhd ("**Samsung**").
- 1.2 The sales transaction in the Promotion is between the Participating Stores (as defined below) and Customer. Samsung only provides the recommended retail price ("RRP") and/or redemption guidance on this site.
- 1.3 Customer agrees to comply with all the above when accessing or using this site. The scope of these Terms and Conditions is limited to Samsung's role of hosting this site and organizing this Promotion only.
- 1.4 The Promotion is on first come first served basis and while stocks last.

#### 2. Promotion Period

- 2.1 The Promotion will run from 15<sup>th</sup> Aug 2022 to 31<sup>st</sup> Oct 2022 or while promotional stocks last, whichever is earlier ("**Promotion Period**"). Samsung reserves the right to amend, shorten, extend or cancel the Promotion Period at its sole discretion without prior notice.

#### 3. Redemption Period

- 3.1 Redemption period starts from 15<sup>th</sup> Aug 2022 to 7<sup>th</sup> Nov 2022 ("**Redemption Period**"). No extension of redemption period will be allowed. Samsung reserves the right to amend the period at any time as they deem fit without prior notice.

#### 4. Eligibility

- 4.1 The Promotion is open to all Malaysian citizens and/or residents of Malaysia of 18 years old and above (as of 15<sup>th</sup> Aug 2022) with Malaysia Identity Card; except Samsung's employees (and their immediate families), its related agencies, retailers and dealers.

#### 5. Participating Stores ("**Dealer**")

- 5.1 Samsung Online Store, Samsung Authorised Online Store and Samsung Authorised Retail Dealers

#### 6. Promotion Mechanism

By participating in the Promotion (please refer to Appendix 1 for participation details), Customer will be eligible to the following promotion(s):

- 6.1 With every purchase of Samsung Products ("**Promotional Products**") as stated in Appendix 1, Customer may redeem free gift as stated in the Appendix 1 ("**Free Gift**").
- 6.2 The Promotional Products, Free Gift and/or E-voucher redemption are on first come first served basis and while stocks last.
- 6.3 Samsung reserves the right to suspend or terminate or cancel the Promotion or change/amend the Promotional Products at its sole discretion anytime without any prior notice.

#### 7. Redemption Process

- 7.1 Customer is required to register or sign in to Samsung Account to submit the redemption at Samsung Redemption Management System. For the purpose of this Promotion, a Samsung Account is required.
- 7.2 Visit <https://samsung-redemption.com/customer/#/sasso/MY-gwp-702> and click "redeem now" to complete the online redemption form and submit within the Redemption Period. Customer will need to enter the following information:
  - i. Email
  - ii. Store of purchase
  - iii. Date of purchase
  - iv. Invoice number
  - v. Model purchased Serial Number
  - vi. Recipient Name
  - vii. Delivery Address

- viii. Contact Number
  - ix. Identification Number
  - x. Upload a copy of Proof of Purchase (the Receipt with Model Code)
- 7.3 Uploaded document must be a PDF document or in an image format (jpg, jpeg or png format). Maximum size of each document is 5MB. Any documents with unclear details may delay the redemption process. Any submission after the Redemption Period will be void.
- 7.4 The redemption request will be processed by Samsung fulfilment partner within 10 business days from redemption submission date and the Free Gift will be delivered to Customer within 30 business days after the end of the Promotion Period. Email notification will be sent out with delivery tracking number.
- 7.5 Customer is not allowed to choose any colour of the Free Gift and the Free Gift will be delivered to Customer based on colour availability. Any request to change colour of the Free Gift will not be entertained.
- 7.6 The Free Gift is not redeemable for cash, not exchangeable, transferable, nor refundable, and cannot be used in conjunction with other promotional offers at the Promotion.
- 7.7 Free Gift's arrival time may differ subject to delivery area and Samsung will not be held responsible for any delay in delivery or lost in delivery
- 7.8 It is the responsibility of the purchaser to ensure all the details stated in the redemption form is accurate. Each email address/ recipients' name/ recipients' address/ mobile numbers/ invoice can only have a maximum of 5 times submission provided all the proof of purchase/receipt is valid. - i. redemption form is incomplete;

  - iii. receipt address is Samsung Partners outlet address;
  - iv. delivery address is incomplete or wrong or non-acceptance of the parcel;
  - v. redemption form or any redemption documents appears to be fraudulent;
  - vi. redemption form is not in accordance with the terms and conditions;
  - vii. if Samsung believes the redemption is fraud or any irregular transaction or being manipulated in any whatsoever manner.
- 7.10 If any of the redemption item(s) are returned to Samsung or the Appointed Delivery Service Provider "unclaimed", Samsung will email to the customer to arrange for re-delivery of the redemption item subject to Customer's reply to the said email within the stipulated timeline. Samsung may impose delivery charges on the re-delivery.
- 7.11 Samsung shall not be liable for any failure on the part of the Customer who fails to submit and/or resubmit the complete redemption form with all the supporting documents within the stipulated timeline and /or any delay or non-delivery, lost delivery, damaged or stolen Free Gift.
- 7.12 In the event of any discrepancies in the information that Customer has submitted for the redemption of Free Gift and for any reasons whatsoever, Samsung shall not be responsible for any loss or costs arising from such discrepancies howsoever caused.
- 7.13 In the event Samsung found or suspected of fraud or any irregular transaction or cheating or hacking or tampering with the redemption process, operation or purchase submission or any violation of any of the Terms and Conditions by the Customer, Samsung reserves the right to recover any damages from such Customer to the fullest extent permitted by law.
- 7.14 Samsung reserves the right to cancel, forfeit, withdraw, suspend the title and ownership of Free Gift(s) in the event there is any non-compliance with the terms and condition stated herein and shall recover any damages from such Customer to the fullest extent permitted by law.
- 7.15 Samsung reserves the right to request the original invoice, receipt and/or any supporting documents required from Customer for verification purpose. For the avoidance of doubt, Samsung reserves the right to determine if the supporting documents are sufficiently genuine for the purposes of the approval of the redemption.
- 7.16 For Adidas E-E-voucher, Customer will receive notification by e-mail from the appointed fulfilment party (HUMANOMICS SDN BHD ("Humanomics")). By providing your personal information including name, contact numbers, email address and other information to Samsung, Samsung can use and/or disclose to Humanomics for the purposes of fulfilment.

- 7.17 Adidas E-E-voucher will be delivered to customer in the form of a unique code that can be redeemed in the respective Adidas Official Website and Adidas mobile app. The redemption must be completed by 31<sup>st</sup> Jan 2023 upon receiving of unique code from Humanomics failing which the redemption will be considered as null and void. Samsung shall not be liable if customer fails to redeem within the stipulated time.
- 7.18 Samsung will not be responsible for the Adidas E-E-voucher usage terms and condition. The usage terms and conditions shall be subject to the original E-voucher vendor

## **8. Payment**

- 8.1 Customer acknowledges, understands and agrees that all transactions are between Customer and Dealer only. Samsung only acts as the coordinating party and is not involved or a party of any monetary/sale and purchase of this order transaction.
- 8.2 Customer is not allowed to cancel the order, change the selected device colour or model, or the selected outlet once Customer has successfully completed and confirmed the payment transaction.
- 8.3 Customer shall pay the full amount for the order directly to Dealer only.

## **9. Delivery**

- 9.1 Order will be delivered within 5-7 working days for Peninsular Malaysia; and 1-2 weeks for East Malaysia subject to stock availability.
- 9.2 The fulfilment and delivery of the product is handled by Samsung SDS Malaysia Sdn Bhd ("SDS").
- 9.3 SDS reserves the right to appoint a third (3rd) party vendor or service provider to handle the fulfilment or making available of the product and delivery of the product to you. By providing your personal information including name, delivery address, contact numbers, email address and other information to SDS, SDS can use and/or disclose to such third (3rd) party vendor or service provider for the purposes of delivery service.
- 9.4 To accept the item, the Customer or the authorised representative or the recipient is required to present identification, i.e. NRIC or Passport to the delivery personnel, failing which the delivery personnel have the right to refuse delivery and will return the product to SDS as "unclaimed".
- 9.5 The proof of delivery of product must be in the form of written acknowledgement of receipt of the product by the Customer, the authorised representative or the recipient. If the delivery address is an office address, an acknowledgement by any office staff will be treated as good acknowledgement of the item.
- 9.6 The time for delivery of the product is between the Customer and SDS. Samsung shall not be liable for any delay in delivery of the product howsoever caused.

## **10. Customer's Covenants**

In connection to this Promotion, Customer will not use this site:

- 10.1 To submit fraudulent order, false, inaccurate, misleading, defamatory, or libelous information;
- 10.2 To distribute viruses or any other technologies that may harm Samsung, or the interests or property of other users;
- 10.3 To export the unit purchased except in compliance with the export control laws of relevant jurisdictions and in accordance with posted rules and restrictions;
