1. Introduction

1.1 The Samsung Galaxy Z Fold4 | Z Flip4 | Watch5 Pro Bluetooth | Watch5 Bluetooth | Buds 2 Pro Pre-Order Campaign (“**Promotion**”) is organized by Samsung Malaysia Electronics (SME) Sdn Bhd (“**Samsung**”).
