EDU Terms & Conditions:

These terms and conditions for EDU are applicable between SME and the participating partner & the EDU user.

Access to EDU is provided to users on the following terms and conditions ("Terms"):

- 1. The EDU users agree to comply with all the terms and conditions herein when accessing or using the e-Store. The scope of these Terms and Conditions is limited to SME's role of hosting this site and organizing promotions or campaigns, as the case may be. The sale transaction is between Samsung SDS Malaysia Sdn Bhd ("SDS") and EDU users. SME only provides the recommended retail price ("RRP") and other information, where applicable.
- 2. Samsung may from time to time, and in its absolute discretion, offer discounts on a product featured in its Online Store ("Product"), or on a range or category of Products, to current or newly-accepted full time or part time students and employees of eligible, accredited educational institutions in Malaysia (including schools, universities and colleges) who have a valid Malaysian educational email address as recognised by Samsung (each an "Eligible Customer").
