Terms and Conditions

1. Introduction

- 1.1. The Galaxy Land @ TRX Raintree Plaza ("**Event**") is organized by Samsung Malaysia Electronics (**SME**) Sdn Bhd ("Samsung").
- 1.2. Participant agrees to comply with all the terms and conditions when accessing or using this site. The scope of these Terms and Conditions is limited to Samsung's role of hosting this site and organizing this Event only.
- 1.3. The Event is on a first come first served basis, and while stocks last.

2. Event Period

- 2.1. The Event will run for the periods as stated below or while promotional stocks last, whichever is earlier ("Event Period"). Samsung shall reserve the right to shorten, extend or cancel the Event Period at its sole discretion without any prior notice.

- 3.2. Employees, dealers or agents of Samsung or any of its group companies or their families or households or anyone connected to this Event are not eligible to participate in this Event.
- 3.3. By participating in this Event, each Participant (interchangeably referred to as "Participant", "You" or "Your") agrees to be bound by these Terms and Conditions.
