

Samsung Galaxy S26 Series Launch Promotion

Terms and Conditions

1. Introduction

- 1.1 The Samsung Galaxy S26 Series Launch Promotion (“**Promotion**”) is organized by Samsung Malaysia Electronics (SME) Sdn Bhd [Company No. 200301026766(629186-D)] (“**Samsung**”).
- 1.2 The sales transaction in the Promotion is between the Participating Stores (as defined below) and Customer. Samsung only provides the recommended retail price (“**RRP**”) and/or redemption guidance on this site.
- 1.3 Customer agrees to comply with all the terms and conditions when accessing or using this site. The scope of these Terms and Conditions is limited to Samsung's role of hosting this site and organizing this Promotion only.
- 1.4 The Promotion is on a first come first served basis, and while stocks last.

2. Promotion Period

Step 1	Eligible Customer with Existing Device to sign-up/pre-register as Galaxy Forever member in Samsung Member app under the “Benefits” section during the Sign Up Period. Note: Eligible Customer will be directed to fulfilment partner, Remobie Technologies Sdn Bhd’s (“ Fulfilment Partner ”) site to complete the sign-up/pre-registration.
Step 2	Upon successful enrolment/sign-up, Galaxy Forever Card with unique Member ID is added to eligible Customer’ Samsung Wallet.
Step 3	Eligible Customer to visit any Participating Stores during the Promotion Period and present the Existing Device with Galaxy Forever Card for assessment and trade-in.
Step 4	The Existing Device will be diagnosed, assessed and graded at the Participating Stores using the Fulfilment Party’s diagnosis tool. Note: <ul style="list-style-type: none"> • Subject to minimum device conditions below (“Minimum Device Conditions”) • The condition assessment and result are strictly between the eligible Customer and Fulfilment Party and subject to the Fulfilment Party’s terms and conditions.
Step 5	Eligible customer to purchase any of the Participating Models from the Participating Stores during the Promotion Period. Based on the condition, eligible Customer will be offered the Residual Value for the trade-in/sale of the Existing Device to the Fulfilment Party. - 5.5.4 By providing your personal information including name, contact numbers, email address and other information to Samsung, Samsung can use and/or disclose to Fulfilment Party for the purposes of fulfilment under this Program.
- 5.5.5 Samsung will not be responsible for the fulfilment/trade-in transaction between the Fulfilment Party and Customer. The trade-in subject to the Fulfilment Party's terms and conditions which the Customer shall adhere to. Samsung is merely acting as the coordinator for the trade-in transaction.
- 5.5.6 Official replacement devices (e.g. warranty claim) with official documentation are eligible for the Program.
- 5.5.7 Eligible Customers shall ensure that all customer data backup is completed and their SIM card is removed from the Existing Device prior to the handover to the Fulfilment Party through the Participating Stores. Upon such handover, the data in the Existing Device shall be deemed as deleted/lost and cannot be recovered/restored. Samsung, the Participating Stores and the Fulfilment Party shall not be held liable for any loss including personal data arising from the Program.

- 7.2 SDS reserves the right to appoint a third (3rd) party vendor or service provider to handle the fulfilment or making available of the product and delivery of the product to you. By providing your personal information including name, delivery address, contact numbers, email address and other information to SDS, SDS can use and/or disclose to such third (3rd) party vendor or service provider for the purposes of delivery service.
- 7.3 To accept the item, the Customer or the authorised representative or the recipient is required to present identification, i.e. NRIC or Passport to the delivery personnel, failing which the delivery personnel have the right to refuse delivery and will return the product to SDS as "unclaimed".
- 7.4 The proof of delivery of product must be in the form of written acknowledgement of receipt of the product by the Customer, the authorised representative or the recipient. If the delivery address is an office address, an acknowledgement by any office staff will be treated as good acknowledgement of the item.
- 7.5 The time for delivery of the product is between the Customer and SDS. Samsung shall not be liable for any delay in delivery of the product howsoever caused.

8 Customer's Covenants
