

## Samsung Galaxy Forever Program

### Terms and Conditions

#### 1. Introduction

- 1.1 The Samsung Galaxy Forever Program ("**Program**") is coordinated by Samsung Malaysia Electronics (SME) Sdn Bhd [Company No. 200301026766(629186-D)] ("**Samsung**"). The terms and conditions herein and the Privacy Policy as mentioned below ("**Terms and Conditions**") will be construed as the terms and conditions of this Program in which Samsung offers you ("**Customer**") to and use of this site for the purposes of this Program
- 1.2 The sales transaction in the Program is between the Participating Stores (as defined below) and Customer. Samsung only provides the recommended retail price ("**RRP**") and/or guidance on this site.
- 1.3 Customer agrees to comply with all of the above when accessing or using this site. The scope of these Terms and Conditions is limited to Samsung's role of hosting this site and coordinating the Program only. For actual fulfilment i.e. trade-in/upgrade transaction, the relevant terms and conditions of Remobie Technologies Sdn Bhd or any other fulfilment party appointed by Samsung ("**Fulfilment Party**") will apply.

#### 2. Program Period

- 2.1 The Program will run from 31 July 2024, 12.00 a.m. to 31 December 2025, 11.59 p.m. ("**Program Period**").
- 2.2 Samsung reserves the right to shorten, extend or cancel the Program Period at its sole discretion without prior notice.

#### 3. Eligibility

- 3.1 The Program is open to all Malaysian citizens and residents of Malaysia of 18 years and above (as of 31 July 2024).
- 3.2 Eligible Customers are as defined hereinunder in relation to the Program.

5.2 Steps to enrol/register for the Program:

<b>Step 2</b>	Eligible Customer enrolls/registers for the Program at the Fulfilment Party's designated platform at <a href="https://my.remobie.com/en/annual-upgrade/galaxy-forever-2025">https://my.remobie.com/en/annual-upgrade/galaxy-forever-2025</a> during the Sign Up Period.
<b>Step 3</b>	Upon successful enrolment/sign-up, Customer will receive confirmation email from Fulfilment Party.

5.3 Eligible Customers who successfully enrolled/registered for the Program are eligible to get guaranteed residual value as set out in section 5 of the appendix ("**Guaranteed Residual Value**") when eligible Customers upgrade their Existing Device per the upgrade journey in paragraph 5.4 below:

<b>Step 3A</b>	<p>The Existing Device will be diagnosed, assessed and graded at the Device Upgrade Participating Stores using the Fulfilment Party's diagnosis tool.</p> <p>Note:</p> <ul style="list-style-type: none"> <li>• Subject to minimum device conditions in paragraph 5.5 below ("<b>Minimum Device Conditions</b>")</li> <li>• Only Grade A &amp; B device will be accepted.</li> <li>• The grading process and result are strictly between the eligible Customer and Fulfilment Party and subject to the Fulfilment Party's terms and conditions.</li> </ul>
<b>Step 3B</b>	<p>Customer to purchase any of the next Galaxy device in section 7 of the appendix ("<b>Next Galaxy Device</b>") from the Device Upgrade Participating Stores during the Upgrade Period.</p> <p>Based on the above grading result, eligible Customer will be offered the Guaranteed Residual Value for the trade-in/sale of the Existing Device to the Fulfilment Party.</p>

### 5.5 Minimum Device Condition

During the upgrade journey, the Existing Device shall be assessed (including functional and physical assessments). The Existing Device that do not meet the Minimum Device Conditions details below will not eligible for the Program:

Turn ON/OFF	Device can be turned on
Product Locks	Device is logged out of personal account e.g. Google Account/ Samsung Account and Passcode
Sim card reading	Device can make and receive calls through cellular network
Back & Side Cover	No cracks or dent
Screen condition	All screens do not show watermark, black spot, white spot, burn spots, green colouring, line, flashing when brightness is adjusted to max and on different color backgrounds. All screens display colour normally.
Touch screen	Touch function work properly in all screen areas
Screens/ Cover	No cracked/ chipped screen
Buttons Functionality	Buttons are responsive and fully functional
Fingerprint/ Face scanner	Fingerprint & face scanner can be detected upon unlocking the device
Camera	All cameras can focus and take photos normally and no cracks in the lens
Speaker/ Microphone Defect	All speakers can produce clear sound & microphones can pick up the sound clearly
Battery and charging	Device can to hold charges and be charged normally
Protector film	Factory's installed screen protector file is in a good shape with no bubble or visible crease
Unfold flat	Device can be unfolded completely flat
Sensors	Sensors function properly (e.g. proximity and gyroscopic sensors)
Wi-Fi/ Bluetooth	Device can connect to wi-fi/ bluetooth normally
Missing Parts	Device does not have any missing original parts (e.g. screws, buttons, sim tray, rubber feet)

5.6 By providing your personal information including name, contact numbers, email address and other information to Samsung, Samsung can use and/or disclose to Fulfilment Party for the purposes of fulfilment under this Program.

5.7 Samsung will not be responsible for the fulfilment/trade-in transaction between the Fulfilment Party and Customer. The trade-in subject to the Fulfilment Party's terms and conditions which the Customer shall adhere to. Samsung is merely acting as the coordinator for the trade-in transaction.

- 5.8 Official replacement devices (e.g. warranty claim) with official documentation are eligible for the Program.
- 5.9 Eligible Customers shall ensure that all customer data backup is completed and their SIM card is removed from the Existing Device prior to the handover to the Fulfilment Party through the Device Upgrade Participating Stores. Upon such handover, the data in the Existing Device shall be deemed as deleted/lost and cannot be recovered/restored. Samsung, the Device Upgrade Participating Stores and the Fulfilment Party shall not be held liable for any loss including personal data arising from the Program.
- 5.10 The final payment for the Next Galaxy Device to be made by the Customer will depend on the Next Galaxy Device purchased and the Existing Device traded-in.
- 5.11 Actual promotion availability is subject to the respective Device Upgrade Participating Stores. Customer is advised to check with point of sales to confirm the promotion type and/or availability of the Program.
- 5.12 Samsung reserves the right to suspend, terminate, cancel, vary and revise the Program at its sole discretion anytime without any prior notice.

## **6. Payment**

- 6.1 Customer acknowledges, understands and agrees that all transactions are between Customer and the Device Upgrade Participating Stores and/or Fulfilment Partner only. Samsung only acts as the coordinating party and is not involved or a party of any monetary sale and purchase of this order transaction.
- 6.2 Customer is not allowed to cancel the order, change the selected device colour or model, or the selected outlet once Customer has successfully completed and confirmed the transaction.

## **7. Customer's Covenants**

In connection to this Program, Customer will not use the site:

- 7.1 To submit fraudulent order, false, inaccurate, misleading, defamatory, or libelous information;
- 7.2 To distribute viruses or any other technologies that may harm Samsung, or the interests or property of other users;
- 7.3 To export the unit purchased except in compliance with the export control laws of relevant jurisdictions and in accordance with posted rules and restrictions;
- 7.4 In the event if Samsung suspects or discovers that the Customer is abusing this Program and/or Samsung in any of the ways mentioned above or otherwise, Samsung may, at our sole discretion, take necessary steps to prevent and mitigate such abuse such as limiting, suspending, or terminating the Customer's user account(s) and access to the site, delaying or removing hosted content, removing any special status associated with Customer account(s), reducing or eliminating any discounts, and taking technical and/or legal steps to prevent Customer from using this site.
