

Samsung MX Registration of Interest & Samsung Reservation+

Terms and Conditions

1. Introduction

- 1.1 The Samsung MX Registration of Interest (“**ROI**”) & Samsung Reservation+ (“**SR+**”) (collectively the “**Promotion**”) is organized by Samsung Malaysia Electronics (SME) Sdn Bhd [Company No. 200301026766(629186-D)] (“**Samsung**”).
- 1.2 The sales transaction in the Promotion is between the Participating Stores (as defined below) and Customer. Samsung only provides the recommended retail price (“**RRP**”) and/or redemption guidance on this site.
- 1.3 Customer agrees to comply with all the terms and conditions when accessing or using this site. The scope of these Terms and Conditions is limited to Samsung's role of hosting this site and organizing this Promotion only.
- 1.4 The Promotion is on a first come first served basis, and while stocks last.

2. Promotion/Redemption Period

- 2.1 The Promotion will run for the periods as stated below or while promotional stocks last, whichever is earlier (“**Promotion Period**”):

- 3.1 The Promotion is open to all Malaysian citizens and residents of Malaysia of 18 years and above (as of 9 July 2025); except Samsung employees (and their immediate families), its related agencies, retailers and dealers.

5. Promotion/Redemption Mechanism

By participating in the Promotion, Customer will be eligible for the following promotion(s) below:

Pre-order any of the Participating Models (but there must be at least one (1) unit of the Next Galaxy Smartphone device(s) unveiled during the Galaxy Unpacked, in the same transaction), during the Redemption Period. 5. Customer to show the ROI Voucher Code to floor sales-person at the point of pre-order. Discount of the corresponding ROI Voucher Code worth RM180 will be deducted from the total bill. 6. Make payment accordingly.

5.1.6 The ROI Voucher Code is not exchangeable for cash, not transferable and not refundable. Unless otherwise stated, the ROI Voucher Code cannot be used (not stackable) in conjunction with other promotional offers including but not limited to Shop App first purchase voucher.

5.1.7 By registering interest, Customer agrees to receive marketing communication from Samsung regarding the Galaxy Unpacked and ROI Voucher Code.

5.2 Samsung MX Samsung Reservation+ (SR+)

5.2.1 Customer who registered interest (by completing and submitting the online ROI form during the ROI Promotion Period) is eligible to purchase the SR+ voucher by paying RM10 during the Promotion Period and receive a voucher code worth RM210 ("**SR+ Voucher Code**"). Steps to purchase the SR+ Voucher Code are as below:

Step 1:	Customer to complete and submit the online ROI form during the ROI Promotion Period.
Step 2:	Customer to enter Samsung MX SR+ buy page upon completing the ROI form.
Step 3:	Customer to select the SR+ Voucher Code, add into cart and proceed to checkout.
Step 4:	The SR+ Voucher Code will be shared to Customer's email within 24 hours.

- 5.2.3 The SR+ Voucher Code is only valid for the pre-order of the Participating Models during the Redemption Period. Each Customer is only eligible to redeem one (1) SR+ Voucher Code during the Redemption Period. The SR+ Voucher Code will be forfeited if not redeemed during the Redemption Period.
- 5.2.4 SR+ Voucher Code is not exchangeable for cash, not transferable and not refundable. Unless otherwise stated, SR+ Voucher Code cannot be used (not stackable) in conjunction with other promotional offers including but not limited to Shop App first purchase voucher. Subject to the Redemption Period, the SR+ Voucher Code can be stacked with ROI Voucher Code (but there must be at least one (1) unit of the Next Galaxy Smartphone device(s) unveiled during the Galaxy Unpacked, in the same transaction).

Checkout and make payment accordingly.
Endless Aisle	1. Walk into any Participating Stores that offers Endless Aisle. 2. Pre-order by adding any of the Participating Models to the cart in Endless Aisle during Redemption Period. 3. At the Confirmation Page, enter a valid SR+ Voucher Code in the Promo Code box and click "Confirm". 4. Discount in the corresponding SR+ Voucher Code (worth RM210) will be automatically reflected. Checkout and make payment accordingly.
Other Participating Stores	1. Walk into any Participating Stores during the Redemption Period to pre-order any of the Participating Models. 2. Customer to show the SR+ Voucher Code to floor sales-person at the point of purchase. 3. Discount of the corresponding SR+ Voucher Code (RM210) value will be deducted from the total bill upon full payment.

- 5.3 All Promotion(s), Participating Model(s), free gift(s) and voucher codes are limited to the quantity stated above on first come first served basis and while stocks last.

- 5.4 Actual promotion(s) availability is subject to the respective Participating Stores. Customer is advised to check with point of sales to confirm the promotion type and/or availability prior to purchase.

- 6.1 Actual collection/delivery period for pre-order is subject to the stock availability of the respective Participating Stores & Participating Model(s). Customer is advised to check with point of sales on actual collection/delivery date prior or upon pre-order of the Participating Model(s).
- 6.2 In the event the Customer fails to collect the pre-ordered Participating Model(s) within the stipulated periods, the deposit amount (as stipulated by the relevant Participating Store) will be forfeited and the pre-order shall be null and void. E-voucher(s) redeemed in the pre-order will not be refundable. For the avoidance of doubt, Customers will be charged the full amount for and upon pre-orders made through Samsung Online Store and Endless Aisle.
- 6.3 Samsung reserves the right to change/update the pre-order collection/delivery period without prior notice and shall not be liable for any changes to the same.

7. Payment

- 7.1 Customer acknowledges, understands and agrees that all transactions are between Customer and Dealer only. Samsung only acts as the coordinating party and is not involved or a party of any monetary/sale and purchase of this order transaction.
- 7.2 Customer is not allowed to cancel the order, change the selected device colour or model, or the selected outlet once Customer has successfully completed and confirmed the payment transaction.
- 7.3 Customer shall pay the full amount for the order directly to Dealer only.

8. Delivery

- 8.1 The fulfilment and delivery of the product is handled by Samsung SDS Malaysia Sdn Bhd ("SDS").
- 8.2 SDS reserves the right to appoint a third (3rd) party vendor or service provider to handle the fulfilment or making available of the product and delivery of the product to you. By providing your personal information including name, delivery address, contact numbers, email address and other information to SDS, SDS can use and/or disclose to such third (3rd) party vendor or service provider for the purposes of delivery service.
- 8.3 To accept the item, the Customer or the authorised representative or the recipient is required to present identification, i.e. NRIC or Passport to the delivery personnel, failing which the delivery personnel have the right to refuse delivery and will return the product to SDS as "unclaimed".
- 8.4 The proof of delivery of product must be in the form of written acknowledgement of receipt of the product by the Customer, the authorised representative or the recipient. If the delivery address is an office address, an acknowledgement by any office staff will be treated as good acknowledgement of the item.
- 8.5 The time for delivery of the product is between the Customer and SDS. Samsung shall not be liable for any delay in delivery of the product howsoever caused.

9. Customer's Covenants

In connection to this Promotion, Customer will not use this site:

- 9.1 To submit fraudulent order, false, inaccurate, misleading, defamatory, or libelous information;
- 9.2 To distribute viruses or any other technologies that may harm Samsung, or the interests or property of other users;
- 9.3 To export the unit purchased except in compliance with the export control laws of relevant jurisdictions and in accordance with posted rules and restrictions;
- 9.4 In the event if Samsung suspects or discovers that the Customer is abusing this Promotion and/or Samsung in any of the ways mentioned above or otherwise, Samsung may, at our sole discretion,

take necessary steps to prevent and mitigate such abuse such as limiting, suspending, or terminating the Customer's user account(s) and access to this site, delaying or removing hosted content, removing any special status associated with Customer account(s), reducing or eliminating any discounts, and taking technical and/or legal steps to prevent Customer from using this site.
