

Samsung Galaxy New Launch Hand Raiser Giveaway

Terms and Conditions

1. The Samsung Galaxy New Launch Hand Raiser Giveaway ("**Contest**") is organized by Samsung Malaysia Electronics (SME) Sdn. Bhd. [Company No. 200301026766(629186-D)] ("**Samsung**").

Duration

2. This Contest will run from 8 July 2026 (7:00 AM) to 22 July 2026 (8:59 PM) ("**Contest Period**"). Samsung shall reserve the right to shorten, extend or cancel the Contest Period at its sole discretion without any prior notice.

3. Eligibility

This Contest is open to participants who are:

- a) Citizens of Malaysia; and
- b) Aged 18 years old and above, as stated on their NRIC/Passport (as of 8 July 2026).

By participating in this Contest, each participant (interchangeably referred to as "Participant", "You" or "Your") agrees to be bound by these Terms and Conditions.

4. Employees, dealers or agents of Samsung or any of its group companies or their families or households or anyone connected to this Contest are not eligible to participate in this Contest.

6. Participants who register their interest for the "Next Galaxy Devices" (with first name, last name and email submitted) within Contest Period will be eligible to participate and stand a chance to win ("**Eligible Participants**" or "**Participants**").

Note: Multiple ROI with different email addresses is allowed.
Step 2	Participant who completes the ROI are eligible to participate in the Contest and stand a chance to win a mystery prize.

9. Eligible Participants can participate everyday throughout the Contest Period. Multiple registration with different email addresses is allowed. Eligible Participants who had registered their interest during the Contest Period are welcome to participate by using different email addresses.
