## **Terms and Conditions**

- 1. These terms and conditions govern the promotional offer (the "Offer") entitling a limited number of eligible Samsung customers who purchase the Galaxy Z Fold6 and Galaxy Z Flip6 Series under the Offer (the "Customer(s)") to receive a Gift after activating their device and setting up a 'Samsung Account'.
- 2. The Offer is only available to Customer(s) who purchase the Eligible Product Models (defined below) from the Samsung E-store (<a href="https://www.samsung.com/pk">https://www.samsung.com/pk</a>) (the "E-store"). This Offer does not include devices purchased out of Pakistan or devices not intended for Pakistan. - 3. The Offer will be available on the Eligible Product Model(s) (defined below) purchased through the E-Store only between 16<sup>th</sup> Sep 2024 (4:00 pm) 2024 till 15<sup>th</sup> Dec 2024 (4:00 pm), or until stocks last, whichever is earlier (the "**Offer Period**").
- 4. The Offer will entitle the Customer(s) who purchase the Product Models detailed in the table below (the "Eligible Product Model(s)"), from the E-store, to receive a gift (the "Gift"), in accordance with the table below, but in the absolute discretion of Samsung and until stocks last:

- 5. The deliveries of the order(s) placed by a Customer during the Offer Period will tentatively start from 23<sup>rd</sup> Sept. 2024. Delivery schedule is subject to availability, depending on all attending circumstances. The standard shipping policy of Samsung or its relevant authorized distributor with respect to mode and manner of shipment will apply. By placing an order for and purchasing the Eligible Product Model(s) on the E-Store within the Offer Period, the Customer will be deemed to have consented to this delivery timeline.
- 6. Once the Customer completes the purchase within the Offer Period, and receives the Eligible Product Model, in order to redeem the Gift the Customer must:
  - 6.1. Activate the Eligible Product Model and set it up;
  - 6.2. If the Customer already has a Samsung Account, then they should log into the Samsung Members Application (a pre-loaded Application on the Eligible Product Model);
  - 6.3. If the Customer does not have a Samsung Account, the Customer must set up their Samsung account and log in to the Samsung Members Application;
  - 6.4. Within the Samsung Members Application, the Customer should click on Benefits (visible on the home page of the Samsung Members Application). This will lead them to a separate page with the Offer banner;

If the Customer fails to attend the confirmation call, a second call will be made within twenty-four (24) hours of the first call.
