

Terms and Conditions: Consumer Promotion - Giftkarte

1. These terms and conditions govern the promotional offer (the “**Offer**”) entitling a limited number of eligible customers (the “**Customer(s)**”) who purchase particular Samsung smartphones (the “**Eligible Product Model**”) during a certain duration to receive a ‘**Giftkarte Voucher**’ as a gift (the “**Gift**”) after activating their device and setting up a ‘Samsung Account’. The provision of the Gift Voucher shall be in accordance with these terms but in the absolute discretion of Samsung.
2. The Gift is being offered by [Giftkarte Technologies (Private) Limited], a company registered in Pakistan (“**GiftKarte**”)
3. The Offer is only available to Customer(s) who purchase the Eligible Product Model (defined below) through the Designated Stores where official stock is available (“**Designated Stores**”). The list of Designated Stores is available at Annexure A. As the Offer is gratuitous and does not involve any consideration, the inability of a Customer to avail the Offer shall not give rise to any claims, vested rights, or expectations against Samsung or its authorized distributors. 4. This Offer does not include devices purchased from out of Pakistan or devices not intended for Pakistan, or purchased from a source other than the Designated Stores.
5. The Offer will be available on the Eligible Product Model(s) mentioned in Annexure B that are purchased between **13th June’2026 till 2nd July’2026** only.
6. Once the Customer purchases and receives the Eligible Product Model, the Customer will be eligible to obtain the Gift Voucher by following the steps mentioned below:
 - 6.1. Activate the Eligible Product Model and set it up;
 - 6.2. If the Customer already has a Samsung Account, then they should log into the Samsung Members Application (a pre-loaded Application on the Eligible Product Model);
 - 6.3. If the Customer does not have a Samsung Account, the Customer must set up their Samsung account and log in to the Samsung Members Application;
 - 6.4. Within the Samsung Members Application, the Customer should click on “Benefits” (visible on the home page of the Samsung Members Application). This will lead them to a separate page with the Offer banner;
 - 6.5. The Customer must then click the “Offer” banner which will redirect them to a page where a voucher will be visible (the “**Voucher**”). The Customer will click on the voucher and will be required to complete a form with their details (Name, CNIC, Email, Phone number, Gender, Age). Any customer who wants to avail this offer must fill this form (in the Samsung Members app) by **10th July, 2026**.
 - 6.6. This offer banner will be visible in the Samsung Members app within 24-48 hours, after activation.
 - 6.7. Eligible customers list will be shared by Samsung with Giftkarte, which will then disburse the voucher to the customers via SMS & Email.
 - 6.8. Samsung and Giftkarte are not responsible for any failure to redeem the Offer due to incomplete, incorrect, or outdated account information provided by the Customer.
 - 6.9. The Voucher Code is only valid up to one year from the date of voucher issuance. Any Voucher Code not utilized within the said period shall lapse and no claim shall be entertained in that regard after the said period.

- 6.10. The Voucher is non-transferable, non-refundable, and cannot be exchanged for cash or any other benefit.
- 6.11. Samsung shall not be responsible for any technical issues, delays, or failures preventing redemption or usage of the Gift.
- 6.12. The Customers must comply with Giftkarte's standard terms of service and privacy policy. Failure to comply may result in immediate termination of the Gift benefits.

General Terms and Conditions

7. Giftkarte shall be solely responsible for providing the Giftkarte services, and under no circumstances shall Samsung be liable for any defects, issues, or problems arising therefrom. The Customer's sole recourse for any claims or disputes related to the Giftkarte services shall be against Giftkarte.
8. Samsung and Giftkarte shall not be liable for any direct, indirect, incidental, or consequential loss or damage arising from participation in this Offer, including but not limited to system failures, network issues, payment errors, or unauthorized access.
9. Samsung's role is limited to facilitating the advertisement and placement of the Offer, and it assumes no responsibility for the actual provision, quality, or availability of Giftkarte's services being provided under this Offer.
10. Customers' personal information will be processed in accordance with Giftkarte's privacy policy and terms of use, which governs the collection, use, and disclosure of personal data. By availing the Offer, the users are deemed to accept such terms and conditions.
11. Samsung does not collect, store, or process any payment or personal data related to the Giftkarte services.
12. The Offer is provided gratuitously, without any additional/separate consideration.
13. The Gift/Voucher Code given under this Offer may not be redeemed nor exchangeable for cash and can only be redeemed at the retail and online stores of Giftkarte's partner brands.
14. Samsung or its Distributors shall be entitled at their sole discretion, to terminate or modify the Offer or to modify, vary, delete or add to any of these Terms and Conditions at any time prior to or during the continuance of this Offer. Such modification or termination shall not create any right to compensation or damages in favour of any Customer or third party.
15. To the fullest extent permitted under applicable laws, Samsung shall not be liable to the Customer for any loss and/or damages of any kind suffered in connection with the purchase and/or use of any of this Offer or the inability to use such Offer.
16. Samsung or its Distributors shall not be liable to the Customer for any loss and/or damages of any kind suffered in connection with the purchase and/or use of this Offer or the inability to use this Offer.
17. By participating in the Offer, the Customer accepts that any dispute of whatever nature, which is directly or indirectly related to these Terms and Conditions or to the Customer, shall be governed by the laws of the Islamic Republic of Pakistan, and shall be resolved by the competent courts at Lahore and the Customer's remedy shall only be against the relevant authorised distributor of Samsung products in Pakistan and not against Samsung or any of its affiliated entities, as the import/assembly and sale of Samsung Products in Pakistan is exclusively carried out by such authorised distributors and not by Samsung itself.
18. If any Form is accepted by system error or on account of mistake after the expiry or lapse of the Offer or the Offer Period or after the stocks have ended, Samsung/its Distributors reserve the absolute discretion to cancel such Forms without affecting the validity of the transaction of sale for the Eligible Product Model.
19. By participating in this Offer, Customers acknowledge and agree to abide by these Terms & Conditions. Samsung and Giftkarte shall not be held liable for any claims or disputes arising out of the misuse of this Offer.
