

## Terms and Conditions

### Samsung Cricket Season Campaign – Regular Offer

1. These terms and conditions govern the promotional campaign being offered as the “**Samsung Cricket Season Campaign – Regular Offer**” (herein also referred to as the “**Offer**”) on the Samsung Gulf FZE (“**Samsung**”) e-store in Pakistan (<https://www.samsung.com/pk/offer/>) (the “**E-Store**”), entitling a limited number of eligible Samsung customers (the “**Customer(s)**”) to receive discounts (“**Discount**”) on the purchase of certain product models of Galaxy Devices, Accessories, and Appliances of the Samsung brand mentioned in the tables 1-7 given below (collectively the “**Eligible Product Model(s)**”).
2. This Offer consists of various sub-offers:
  - i). **Sub-Offer 1: Discounts plus Multi-Buy Offer – Table 1**
    - a. On the purchase of certain smartphones mentioned in Table 1 together products listed in the last column of the same Table in the same cart, you get a discount on the purchase of the products listed in the last column of that Table. In case, there is a discount mentioned against that product in Table 1, you also get a discount as stated.
  - ii). **Sub-Offer 2: Discounts offered on items in Tables 2 and 3:**
    - a. certain Smartphones of Eligible Product Models mentioned in Table 2
    - b. certain TV, Washing Machine, Refrigerators, RAC, Dishwashers, and Monitors mentioned in Table 3.
  - iii). **Sub-Offer 3: Buy More Save More:**
    - a. When you purchase (i) one Eligible Product from Table 4, and (ii) one Eligible Product from Table 5, in the same cart, you get a discount on the Table 5 Product, as stated in the last column of that table.
    - b. When you purchase (i) one Eligible Product from Table 4, (ii) one Eligible Product from Table 5, and (iii) one Eligible Product from Table 6, you get a discount on the Table 5 Product, as stated in the last column of that Table and also a discount on the Table 6 Product, as stated in the last column of that table.
  - iv). **Sub-Offer 4: Bundles (TV + Smartphone) by using of Voucher Code:**

When you purchase certain Smartphones and TV of Eligible Product Models mentioned in Table 7, in the same cart, you get a discount on the total value of the bundle as mentioned in Table 7, by using the Voucher Code mentioned in the last column of that Table.
3. In some cases, where the Eligible Product Models in **Table 4** are also listed in **Tables 2 or 3**, the Customer may also receive Discount, in accordance with **Table 2** or **3**. Therefore, to that limited extent only, **Offer 2** and **Offer 3** can be clubbed together, subject to the terms and conditions stated herein.
4. The Offers will be available only on the Eligible Product Model(s) which are sold on the E-Store, from **15<sup>th</sup> April (3pm) till 30<sup>th</sup> April 2026 (4pm)**, or until stocks last, whichever is earlier (the “**Offer Period**”).

### Sub-Offer 1: Discounts plus Multi Buy Offer

On the purchase of certain smartphones mentioned in Table 1 together products listed in the last column of the same Table in the same cart, you get a discount on the purchase of the products listed in the last column of that Table. In case, there is a discount mentioned against that product in Table 1, you also get a discount as stated.

In order to avail a discount on the bundles mentioned in Table 7, the Customer(s) must use the voucher code mentioned in the last column of that table. The Discount on the products given in Table 7 can only be applied if the said products are purchased in the same transaction (in a single cart) and the voucher code is used. No discount can be claimed on a different bundle configuration.

#### General Terms and Conditions

10. Samsung and its distributors reserve the right to change the prices of the Eligible Products Model(s) at any time before an order for the Eligible Products Model(s) is confirmed, particularly in case of the economic situation of the country, devaluation and import related problems. The Discount shall be applied, and the final prices will be calculated on the basis of the prices displayed on the E-Store at the time of the purchase. Samsung shall not be liable to the Customer for any price variation occurring prior to order confirmation. All orders shall remain subject to verification and confirmation by Samsung and/or its authorized distributor. Samsung and/or its authorized distributor reserve the right to cancel any order in case of pricing error, system errors or stock unavailability.
11. Samsung shall be entitled at its sole discretion, to terminate or modify the Offer, or to modify, vary, delete or add to any of these Terms and Conditions at any time prior to or during the continuance of any of this Offer. Such modification or termination shall not create any right to compensation or damages in favour of any Customer or third party.
17. To the fullest extent permitted under applicable laws, Samsung shall not be liable to the Customer for any loss and/or damages of any kind suffered in connection with the purchase and/or use of any of this Offer or the inability to use such Offer.
18. By availing this Offer, the Customer accepts that any dispute, claim or controversy arising out of or in connection with these Terms and Conditions, shall be governed by and construed in accordance with the laws of the Islamic Republic of Pakistan. Exclusive jurisdiction shall lie with the competent courts at Lahore. The Customer further acknowledges that the importation, assembly, marketing, and sale of Samsung products in Pakistan are carried out exclusively by Samsung's authorized distributors and not by Samsung itself. Accordingly, any claims or remedies shall be pursued solely against such authorized distributors.
19. The Terms and Conditions of the E-Store, as available at <https://www.samsung.com/pk/terms-and-conditions>, shall apply in addition, but subject to, these terms. In case of any inconsistency between these Terms and Conditions and the E-Store Terms, these Terms and Conditions shall prevail for purposes of the Offer.
20. Unless otherwise expressly stated herein, Samsung discourages Bulk Buying i.e., any order for the purchase of more than 2 units by a single individual or from the same address or from the same payment source, are considered as Bulk Buying and includes placement of multiple orders by a single person/entity. As a result, all those orders which in the opinion of Samsung are likely to be part of Bulk Buying, may be cancelled by Samsung. Samsung shall be the sole judge in this regard.
21. If any order is accepted by system error or on account of mistake after the expiry or lapse of the Offer(s) or after the stocks have ended, Samsung may cancel such orders. The relevant seller (as specified in the Terms and Conditions of the E-Store) will then attempt to provide a full refund of the payment (if any) received by it within fifteen (15) working days after the end of the Offer Period. The Customer acknowledges and understands that the sale contract is between the Customer and the relevant seller to whom payment is made, and Samsung is not liable for any dispute regarding the payment or the refund.
