## **Terms and Conditions**

- 1. These terms and conditions govern the promotional offer (the "Offer") entitling a limited number of eligible Samsung customers who purchase the Samsung Galaxy S24 series (the "Customer(s)") to receive a Gift after activating their device and setting up a 'Samsung Account'.
- 2. The Offer is only available to Customer(s) who purchase the Eligible Product Models (defined below) from the Samsung E-store (<a href="https://www.samsung.com/pk">https://www.samsung.com/pk</a>) (the "E-store") or through any other officially announced modes listed in Annexure A of these Terms and Conditions ("Other Mode(s)"). This Offer does not include devices purchased out of Pakistan or devices not intended for Pakistan. The Offer is also not available on purchases made through any modes or channels other than the E-store and those mentioned in Annexure A.
- 3. The Offer will be available on the Eligible Product Model(s) (defined below) purchased between 12<sup>th</sup> March (12:00 am) 2024 till 29<sup>th</sup> March 2024 (11:59 pm) only, and through the E-Store or Other Mode(s), or until stocks last, whichever is earlier (the "**Offer Period**").
- 4. The Offer will entitle the Customer(s) who purchase the Product Models detailed in the table below (the "Eligible Product Model(s)"), from the E-store or through Other Modes, to receive a gift (the "Gift"), in accordance with the table below, but in the absolute discretion of Samsung and until stocks last:
