

## Terms and Conditions

### Offer

These terms and conditions govern the promotion being extended as “NPS Raffle draw” (the “Offer”), entitling a limited number of individuals who will take part in the feedback survey by filling out a form on the website set up for this purpose at (<https://survey3.medallia.com/?web&c=32&lng=en>) (“S.com”) to enter into a Lucky Draw and get a chance to win a discount Voucher (“Lucky Draw Voucher”), which voucher may be utilized for any MX products available on [\[add the relevant link here\]](#) (the “E-Store”) only, in the absolute discretion of Samsung Gulf FZE (“Samsung”).

- (a) Under this Offer, a Lucky Draw will be conducted on or around the 4<sup>th</sup> or 5<sup>th</sup> day of a calendar month, in the manner set out in these Terms and Conditions. A separate Lucky Draw will be held for each calendar month, until the time Samsung, in its absolute discretion, chooses to discontinue the draws.
- (b) The individuals willing to avail the Offer, will have to complete the feedback survey form (the “Form”) and submit it **on or before the 3<sup>rd</sup> day of every month (11:59 PM)**, to have themselves registered for the **upcoming** Lucky Draw for that month. The interested individual must complete the entire Form and submit the same in order to be eligible for this Offer.
- (c) Entries received after the aforesaid deadline will automatically be entered into the Lucky Draw for the next calendar month, unless Samsung, in its absolute discretion, chooses to discontinue the draws.
- (d) By filling and submitting the complete Form in the foregoing manner, such individuals (“**Eligible Customers**”) will become entitled to partake in the upcoming Lucky Draw being offered under the Offer, but in the absolute discretion of Samsung.
