	National Qualifiers will be conducted by each participating country, Malaysia, Singapore, Indonesia, and the Philippines. The National Qualifiers Stage will follow a single-elimination tournament format, with two slots from each qualifier advancing to the National Finals.
	In the National Finals, 16 teams from each country (Malaysia, Singapore, Philippines) and 8 teams from Indonesia will compete in a single elimination tournament format. The top two teams from each country will then progress to the Cross-National Finals.
	The Cross-National Finals will feature a total of eight teams, with two teams representing each country. The tournament will follow a single elimination format.
