## **The Promoter**

1. The Promoter is Samsung Electronics (UK) Limited of Samsung House, 2000 Hillswood Drive, Chertsey Surrey KT16 OPS

## Eligibility

- The Promotion is open to UK (excluding Northern Ireland) and ROI residents aged 18+ who accept
  these Terms and Conditions, hold a Samsung account and have registered at least one (1) payment
  card in the Samsung Pay App ("Eligible Card") linked to their Samsung Account (each a "Participant"
  and together the "Participants");
- 3. Employees or agents of the promoter or any of its group companies, their families or households and anyone else professionally connected to this promotion are not eligible to participate.

#### **Promotion Period**

4. The Promotion will commence at 12:01 (GMT) on 15 June 2022 and will close at 23:59 (GMT) on 1st July 2022 or until all seven thousand five hundred (7,500) vouchers are gone, whichever occurs earliest (the "Promotion Period").

#### Prize
