TERMS AND CONDITIONS

Participants agree to be bound by these terms and conditions (the "Terms and Conditions"). Any information or instructions published by the Promoter about the Promotion at www.samsung.com/uk/offer/samsungpaygiveawaydisneyplus form part of the Terms and Conditions.

The Promoter

1. The Promoter is Samsung Electronics (UK) Limited, Samsung House, 2000 Hillswood Drive, Chertsey, Surrey, KT16 ORS (the "Promoter" or "Samsung").

Promotion Period

The Promotion will commence at 00:01 BST on 10 September 2023 and close at 23:59 BST on 23 September 2023 or until all eighty thousand (80,000) Disney+ Vouchers are gone, whichever occurs earliest (the "Promotion Period").

Eligibility

- 3. To be eligible to participate in the Promotion you must be a UK/ROI resident aged 18 or over who accept these Terms and Conditions, hold a Samsung account and have registered at least one (1) payment card in the Samsung Wallet App ("Eligible Card") linked to your Samsung account on a mobile device (each a "Participant" and together the "Participants").
- 4. Employees or agents of the Promoter or anyone professionally connected to this Promotion and any group company of the Promoter is not eligible to enter.
- 5. Maximum one (1) claim per Samsung account and per Samsung device during the Promotion Period.

- 14. Use of the Disney+ Code is subject to registration of a Disney+ account and Disney's Subscriber Agreement, available at https://www.disneyplus.com/en-gb/legal/subscriber-agreement.
- 15. The Disney+ Code is redeemable until 23:59 BST on 30 September 2023. A Disney+ Code is not redeemable or refundable for cash and cannot be resold or combined with any other special or free offers, or exchanged for Disney+ gift subscriptions. Minimum spend £0.01 per Transaction (an "Entry").
- 18. Participants only qualify for one (1) Entry per device and Samsung account. Any transactions or purchases made after the Promotion Period will not generate an Entry.

Voucher Redemption

- 25. The Participant will create a Disney+ account, select the offer, input their details and accept the Disney Subscriber Agreement and Privacy Policy on https://www.disneyplus.com. Subscription to the Disney+ service is governed by the Disney+ Subscriber Agreement.

- 26. A valid debit or credit card is required, and by redeeming the Disney+ Code you will be entering into a monthly subscription. You can cancel your subscription at any time before the end of the three (3) month subscription and not be charged. At the end of the three (3) month subscription the Participant credit/debit card will automatically be charged at the then Disney+ Premium price (currently GBP 10.99 p/month EUR 10.99 p/month) unless cancelled.
