By entering this Promotion (the "**Promotion**") Participants agree to be bound by these terms and conditions (the "**Terms and Conditions**"). Any information or instructions published by the Promoter about the Promotion at www.samsung.com/uk/offer/samsungpaygreggs form part of these Terms and Conditions.

#### The Promoter

1. The Promoter is Samsung Electronics (UK) Limited of Samsung House, 2000 Hillswood Drive, Chertsey, Surrey KT16 ORS.

## Eligibility

- 2. To be eligible to participate in the Promotion you must be a UK resident aged 18 or over who accept these Terms and Conditions, hold a Samsung account (and register it to Samsung Wallet for the first time) and register at least one (1) eligible payment card in the Samsung Wallet App for the first time (each a "Participant" and together the "Participants").
- 3. The Promotion is available to Samsung Wallet users who add a debit or credit card during the promotion window
- 4. Maximum one (1) Voucher (defined below) per Samsung account and per Samsung device during the Promotion Period.
- 5. Employees or agents of the promoter or any of its group companies, their families or households and anyone else professionally connected to this Promotion are not eligible to participate.

#### **Promotion Period**

## **Privacy and Data Protection**
