

Giveaway Terms and Conditions

Samsung Flip Park Notts Merch Giveaway Full Terms & Conditions

Please read these terms and conditions carefully. These terms and conditions apply to the Samsung Flip Park Notts event Merchandise Giveaway Promotion (the '**Promotion**'). These terms and conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Entry/claim instructions are deemed to form part of the terms and conditions and by participating or by accepting the prize you will be deemed to have accepted and be bound by the terms and conditions.

1. **The Promoter:** Samsung Electronics (UK) Limited, Samsung House, 2000 Hillswood Drive, Chertsey, Surrey, KT16 0RS, UK.
2. **Eligibility:** This promotion is open to any person aged 7 years or over who visits the Samsung Flip Park Notts event on Saturday 13th April between 10am – 7pm, except for anyone directly connected with the planning or administration of the Promotion including the Promoter's employees, the Promoter's agencies and their immediate families.
3. The Promotion runs on Saturday 13th April between 10am – 7pm ('**Promotional Period**'). The Promotion starts when the Flip Park Notts event opens and closes when all merchandise has been claimed, or when the event has finished, whichever is soonest.
4. **Entry Instructions:**
 - a. Visit the Samsung Flip Park Notts event at Weekday Cross, Nottingham NG1 2GB between 10am – 7pm on Saturday 13th April and obtain a stamp card.
 - b. Participate at all three Samsung stations and ask a Brand Ambassador to stamp your stamp card at each station (Coffee Selfie, Galaxy Table and Galaxy Z Flip5 Selfie).
 - c. Take your completed stamp card to the merchandise stand to claim your merchandise.
5. No third party or bulk entries. If it becomes apparent that either a participant, household or consumer group is using any means to circumvent this condition such as, and without limitation, using multiple identities, fraudulently falsifying data, acting fraudulently or dishonestly in the opinion of the Promoter or otherwise acting in violation of these terms, these participants will be disqualified, and any merchandise entitlement will be void.
6. **Merchandise:**
 - a. There are 50 pieces of merchandise available to be given away in total throughout the Promotional Period.

b. The merchandise is allocated as follows:

The first 50 participants each receive a Drop in With Samsung Cap and a sticker sheet.

c. Once a participant has claimed a piece of merchandise, they cannot claim another throughout the Promotional Period.

d. Once all merchandise has been claimed, the Promotion will end.

7. General:

- a. The Promoter reserves the right to verify participants, and also ask for proof of identity and address and to withdraw merchandise entitlement where there are reasonable grounds to believe there has been a breach of these terms and conditions.
- b. The merchandise must be accepted as offered by the participant. There is no cash or alternative merchandise, in whole or part. The merchandise is not transferable.
- c. The Promoter reserves the right to provide alternative merchandise of equal or greater value should circumstances outside its control make this necessary.
- d. Promoter's decision is final and binding. No correspondence will be entered into.
- e. The Promoter reserves the right, at its sole discretion, to eliminate or disqualify any participants that it regards as being in breach of these terms and conditions or the spirit of the Promotion. Those who try and circumvent the claim process and/or entry instructions by any method, will be disqualified and any claim will be void.
- f. Entry into the Promotion is at the entrant's sole risk. To the extent permitted by law, the Promoter does not accept any responsibility for any damage, loss, liabilities, injury, costs, expenses or claims (whether in contract, tort or otherwise) suffered by entrants or any third parties arising out of or in connection with the Promotion and/or accepting the prize. The Promoter further disclaims liability for any injury or damage to entrants or any other person relating to or resulting from participation with this Promotion save that nothing in these terms and conditions shall act to limit or exclude the Promoter's liability resulting from its negligence or fraud. The Promoter will award the prize as described in these Terms, but the Promoter accepts no responsibility or liability for the participant's use of the merchandise.
- g. The Promoter accepts no responsibility for system errors or other issues that may result in disruption to, lost, delayed or not received claims The Promoter or its agencies will not

be responsible for the non-inclusion of claims as a result of human error, technical failures or otherwise, including any such failure which is within the control of the Promoter or its agencies.

- h. The Promoter reserves the right to cancel, amend, withdraw, terminate or temporarily suspend this Promotion in the event of any unforeseen circumstances or technical reason outside its reasonable control, with no liability to any entrants or third parties but will use all reasonable endeavours to avoid consumer disappointment. Such circumstances include, but are not limited to industrial action, civil unrest, fire, flood, storms, earthquakes, acts of terrorism, acts of war, governmental action or any other event that is beyond the control of the Promoter.
- i. The application and interpretation of these terms and conditions shall be governed by the law of England and Wales and the courts of England and Wales shall have exclusive jurisdiction in relation to any dispute concerning them.
