# TERMS AND CONDITIONS FOR THE SAMSUNG CARE PLUS (12 MONTHS SERVICE PLAN) PROMOTION FOR GALAXY Z FOLD4 and Z FLIP4

Please read this Promotion terms and conditions ("Terms and Conditions") carefully. Participation in this Promotion will constitute your agreement to comply with these Terms and Conditions. - 1.2 The promoter of the Promotion is Samsung Electronics South Africa (Proprietary) Limited, Registration number: 1994/003872/07 and/or its agencies ("Organizer").

#### 2. Promotion Period:

- 2.1 The Promotion will run from **26**<sup>th</sup> **August 2022 at 00h00 until 28**<sup>th</sup> **February 2023** at 23h59. ("Promotion Period") in the Republic of South Africa.
- 2.2 The Promotion Period may be extended or curtailed at the discretion of the Organizer.
- 2.3 The Promotion is valid while stocks last.

## 3. Who may enter:

- 3.1 All participants must:
  - (a) be citizens of the Republic of South Africa and/or legal residents of the aforesaid country;
  - (b) be currently residing in the Republic of South Africa at the date of the commencement of the Promotion Period;

  - (c) have purchased the Device during the Promotion Period;

  - (e) select your qualifying Device from the drop down menu as per the Device bought by the participant;
  - (f) select your 12 Month offer and complete the Samsung Care Plus enrolment form:
  - (g) You MUST complete the Samsung Care plus registration within 30 days from device purchase, otherwise you will lose this limited Offer.
- 4.2. No claims for or activation of the Offer will be accepted or processed after30 March 2023 (23h59);
  - Proof of purchase of the Device may be required as part of the redemption process.

# 5. Can I qualify more than once for the Promotion:

- 5.1. The Promotion is limited to 1 (one) Samsung Care Plus plan per valid Device purchased (identifiable by the unique IMEI number).
- 5.2. Should there be any dispute in this regard, the Organizer shall be sole adjudicator of the dispute and the Organizer's decision shall be final.

#### 6. **Offer:**

- 6.1. The Promotion will afford the participant the opportunity to receive a onceoff promotional 12 months Samsung Care Plus plan ("Offer").

- 7.7. Step 4: Select Samsung Care Plus Standard (Complimentary) option which will have a zero amount.
- 7.8. Step 5: You will receive a SMS and email with your Samsung Care Plus documents within 30 days.

## 8. **Limitation of Liability:**

- 8.1. To the extent permitted by Consumer Protection Act No 68 of 2008 and any other applicable law:
  - (a) The participant and/or winner(s) hereby indemnifies the Organizer against any direct, indirect, special, incidental, consequential or punitive damages or loss of any kind regardless of how this was caused, and whether it arose under the law of contract or delict or otherwise, because of the participants entrance to the Promotion.
  - (b) The Organizer excludes all warranties (express or implied), representations and liabilities regarding this Promotion (other than for death or personal injury caused by its negligence and/or fraud).
