All participants during the term of this Promotion agree to be bound by the following Terms and Conditions.

1. Promotion:

- 1.1. The promotion will be known as the Samsung Galaxy S25 Series (S25, S25+ and S25 Ultra) Trade-In promotion ("**Promotion**").
- 1.2. The organiser of the Promotion is Samsung Electronics South Africa Proprietary Limited, registration number 1994/003872/07 and/or its agencies ("**Organiser**").
- 1.3. "Additional Value" means the difference between the Trade-In Value (as defined in clause 5.3) and the amount paid to a participant.
- 1.4. **"Online Store**" means the Samsung online store and any other online store in South Africa.
- 1.5. **"Participating Network Operator"** means all South African network operators who sell the Promotion Device.
- 1.6. **"Participating Retail Partner"** means the participating South African retail partners listed at the bottom of the webpage https://www.samsung.com/za/trade-in.
- 1.7. **"Promotion Device"** means a Samsung Galaxy S25 Series (S25, S25+ and S25 Ultra) device;
- 1.8. **"Trade-In Device"** means the mobile devices set out in clause 5.1;
- 1.9. **"Trade-In Partner"** means Regener8 Group Proprietary Limited, registration number 2017/308339/07 and/or its agencies.
- 1.10. This Promotion may not be applied for on behalf of someone else and accordingly, only the participant acting in their individual/own capacity can apply. Any application made by a third party on behalf of a participant is strictly prohibited and will result in immediate disqualification from participation in this Promotion.

2. Promotion and Redemption Periods:

- 2.1. The Promotion will run from 21 March 2025 [00h00] to 06 April [23h59] ("**Promotion Period**").
- 2.2. The redemption period will be from 21 March 2025 [00h00] to 13 April 2025 [23h59] ("Redemption Period").

3. Who may enter:

- 3.1.5. during the Promotion Period, have purchased a Promotion Device from a Participating Retail Partner, Participating Network Operator or an Online Store and have a valid proof of purchase for verification by the Organiser.
- 3.2. Participation in this Promotion includes the Organiser, its directors, members, partners, employees, agents, consultants, any other person who directly or indirectly controls or is controlled by them or any supplier of goods and services, if they have personally purchased a Promotion Device for their own personal use from a Participating Retail Partner. Proof of purchase will be at the Organiser's discretion.

- 4.2. Notwithstanding the provisions of clause 4.1 and for the purposes of the definition of "Exclude" set out in the table above, any Trade-In Device:
- 4.2.1. with a crack on the displays;
- 4.2.2. not powering on or reliant on external power;
- 4.2.3. which has battery swelling;
- 4.2.4. which is a foreign device, suspicious and/or deemed to be suspicious trade-in activity; is expressly excluded from this Promotion.
- 4.3. The grading of the Trade-In Device will be at the absolute and sole discretion of the Trade-in Partner and its decision in this regard will be final.
- 4.4. Proof of purchase will be verified at the Organiser's sole discretion.
- 4.5. Errors and omissions may be accepted at the Organiser's discretion. Failure by the Organiser to enforce any of its rights at any stage does not constitute a waiver of those rights.

5.2. How the Offer will apply:

- 5.2.1. Participants paying cash for the Promotion Device from a Participating Retail Partner
- 5.2.1.1. Where the participant is paying cash for the Promotion Device from a Participating Retail Partner, the participant will qualify, subject to the provisions of clause 5.2.1.2, for one of the following, each to the value as set out in clause 5.1:

- 5.4.2. the Promotion Device purchased by the participant is not made for the South African market; or

 - **Step 3:** Access the Trade-In online site via <u>https://www.samsung.com/za/trade-in</u> and select the Promotion Device. Provide the Trade-In Device details, evaluation criteria, personal information for device collection and pay-out details, as applicable and upload the Promotion Device proof of purchase.
 - **Step 4:** The Trade-In Device will be collected by the Trade-In Partner or their agent for evaluation and grading in accordance with the provisions of clause 4.1.3.
 - Step 5: Once a participant receives the applicable Trade-In Value for their Trade-In Device from the Trade-In Partner, the participant will be required to agree to the Trade-In Partner's terms and conditions.

In the event however, of any conflict between the advertising material and these Terms and Conditions, these Terms and Conditions will prevail.
- 10.9. The Organiser may in their sole discretion amend these terms and conditions at any time, without notice, and such amendments shall be deemed to have taken effect from the date of publication of the revised terms and conditions on the website https://www.samsung.com/za/trade-in/
- 10.10. The onus rests on the participant to constantly check the website for updates to the terms and conditions.

11. Consumer Protection Act:
