Terms and conditions

The following Terms and Conditions apply to the pre-order of Galaxy N20 Ultra (N985) and N20 (N980) -and by your participation you are deemed to have read, understood, and accepted the same.

- (a) "Closing date" of the Device Pre-order shall be on 28th August 2020 8:00PM. Samsung reserves the right to end the pre-order earlier than the end date and time specified should it deem it necessary.
- (b) "Customer/User" or "you" means a person who is eligible to participate. An eligible Customer is one who is currently resident in Kenya and over 18 years of age at the time of commencement of the pre-order.
- (c) "Device" shall mean either of the Galaxy N20 Ultra (N985) and N20 (N980) and "Devices" shall refer to all of them collectively.
- (d) Pre-order Period refers to the specified timelines within which a customer can purchase a device and shall be between 14th August 2020 until 28th August 2020.
