<b>Serial numbers and copies of tax invoices</b>	<p>1. If an entrant is unable to provide the serial number and serial number photo of their Participating Product at the time of submitting the Online Entry Form, the entrant must still submit the Online Entry Form during the Redemption Period and tick the relevant box to indicate they have not yet received their Participating Product. EFT payments will only be made into Australian bank accounts. If an Eligible Entrant does not hold an Australian bank account, the Eligible Entrant should contact Samsung directly to discuss whether there are any potential alternative payment options. Samsung is not liable for any EFT payment not being made to, or received by, the Eligible Entrant because the Eligible Entrant does not hold an Australian bank account.</p> <p>3. Eligible Entrants should allow thirty (30) days from the date their claim is deemed valid by Samsung or its agent for the EFT to be made to their nominated bank account, and may need to allow several days thereafter for the funds to clear.</p> <p>4.
