Eligible Reseller are responsible for ensuring their correct contact number, email address and address details are provided and any updated details are notified to the Promoter. The Promoter accepts no responsibility should an Eligible Reseller fail to receive their Gift because of a failure to provide correct details or to notify of a change to those details, or for providing an invalid serial number.
 7. Eligible Resellers should allow forty-five (45) days from the date their claim is deemed valid by the Promoter for the Gift to be received. The Eligible Reseller may need to allow further time for the Gift to be delivered to the Eligible Resellers' address.
