

## **Samsung Pay Gear S3 Bundle Promotion 2018 (Promotion)**

Terms and Conditions (T&Cs)

### **Eligible Entry**

Eligible Entrants who, during the Promotional Period:

1. upload an Eligible Payment Card or Eligible Loyalty Card to Samsung Pay on their Compatible device;
2. follow the prompts to participate in the Promotion, including by agreeing to these T&Cs; and
3. make at least three (3) purchase using their Eligible Payment Card on Samsung Pay on their Compatible Device,

will receive a Voucher Code which can be redeemed on the Gear S3 Bundle on the Samsung Online Store prior to the Redemption End Date (subject to these T&Cs).

### **Notes:**

- (a) In order to submit an Eligible Entry, Eligible Entrants need to have registered a Samsung Account and linked it to Samsung Pay on their Compatible Device.
- (b) Eligible Entrants who submit an Eligible Entry will receive the Voucher Code via a pop-up notification in Samsung Pay as well as a notification in the Promotions area on Samsung Pay.
