I.	Name of the Offer	Buy Galaxy S20/S20+/S20 Ultra and be eligible to purchase Galaxy Buds+ at ₹3999.00 ("Offer").
II.	Provided by	Samsung India Electronics Pvt. Ltd. This is a discretionary Offer, customers may avail the same at their sole discretion.
