## 8. The Gift

## 9. Total Prize Value

## 10. Operation of the Promotion and request of the Gift

All consumers acquiring one or more Promoted Products during the period of offer of the Promotion will have the right to receive one Gift per category of prizes.

Eligibility for participation in the Promotion is based on the serial number of the Promoted Product.

The consumer must register to participate in the Promotion **within 10 days from the date of purchase** within the period between the 30<sup>th</sup> of November 2013 and the 8<sup>th</sup> of December 2013. Registration for participation made after the 8<sup>th</sup> December 2013 will be considered invalid.

For registration, the participant is requested to fill up a form which can be downloaded from the website [www.samsung.it/anticipailnatale](http://www.samsung.it/anticipailnatale), fill up all areas marked with asterisk after having read the privacy policy and provides his/her consent to data processing for the purposes of this Promotion.

When the form is filled up, by pressing the button "Send" the form is sent to Jakala Marketing Solutions Spa. that will verify that the form has been completed correctly.

The participant must :

- Indicate the serial number by which s/he intends to participate in the promotion.
- Register the personal data : name surname id card number or vat number (if available) mobile number address and country.
- Indicate the data of purchase which must be the same as on the proof of purchase.
- Indicate which gift s/he has chosen from the available products.
- Upload on the website [www.samsung.it/anticipainatale](http://www.samsung.it/anticipainatale) the proof of purchase together with a photo of the serial number of the product purchased.

The participant is requested to keep all original documentation at least until the 5<sup>th</sup> of April 2014 since Samsung might ask for the original documents to be sent again if the form is not properly compiled as instructed above. In addition one must also consent to the processing of personal data for the purposes of registration to Samsung Exclusive and for the participation in the Promotion. Failure to abide by these instructions will exclude the consumer from participating in the Promotion.

**Requests for the conformity of the proof of purchase:**

**Validation of the proof of purchase.**

Samsung or the delegated company will verify the proof of purchase and the photo of the Serial number received and the conformity for the participation in the promo.

In the case that everything is in conformity the delegated company will send an email of conformity called Validation proof of purchase.

In the case that there is something wrong the email you will receive is an email of NON VALIDITY of the proof of purchase.

In the case where the proof of purchase or the photo are unreadable the participant will receive an email to verify the proof of purchase and within 3 days a new photo and clear proof of purchase must be sent. If the email is sent later the participant will lose the right to participate and will be disqualified.

If the participant doesn't receive a reply to his request he must resend the registration again in time.

In case the participant does not read or receive his email due to his/her negligence or for any other reason not in the control of Samsung the participant will lose the right to participate and will be disqualified.

#### **11. Manner in which the Gift shall be delivered.**

The participant eligible for the gift will collect the Gift from Sound Machine when the gift arrives which might take up to **6 months** from the date of purchase.

On collecting the gift the participant must produce his/her ID CARD and also proof of purchase and registration confirmation.

The Participant will be informed via telephone and/or email that the Gift is ready for collection. Participant shall by not later than seven (7) working days collect the Gift from Sound Machine. Failure to make this collection within the stipulated timeframe, will lead to forfeiture of Participant's entitlement to the Gift"

The Promoter reserves the right to verify that everything is in accordance with the requisites of the said Promotion. The Promoter reserves the right to request the following information:

- original proof of purchase
- certification from the reseller who states the product was bought during the period of the Promotion
- copy of the id card of the Participant.

In case of non conformity in the various phases specified in Articles 9 and 10 of these Terms and Conditions and in the proof of purchase and/or in the model code, participation in the Promotion shall not be allowed. This will also happen in case that it will result that the data submitted is incorrect.

Fraudulent tempering and external pressures on the registration site might subject the individual to criminal prosecution

The Promoter will not be held responsible for events out of its control, including but not limited to the following situations: the access, bar to access, the malfunction and difficulties relating to the technical instruments, the
