

PRIVACY NOTICE – LET’S DANCE CONTEST

At Samsung Electronics Nordic AB (“Samsung”, “we”, “us”, “our”), we know how important privacy is to our customers. We created this privacy notice (“Privacy Notice”) which applies to the “Let’s Dance Contest” (“Contest”) available on our Facebook profiles called *Samsung Suomi* (the “Facebook Profiles”) and Samsung Members App. This Privacy Notice applies regardless of whether you use a computer, mobile phone, tablet, TV, home appliance device, or other smart device to access the Contest. This Privacy Notice does not apply to Facebook and their respective processing of personal data.

Our privacy notice at <https://account.samsung.com/membership/terms/privacypolicy> (“Privacy Notice For Members”) also applies to your use of Samsung Members. Our Samsung Members privacy notice contains more information about how we use your data. It also includes information about your rights and how to contact us. Please read our Privacy Notice For Members in addition to this Privacy Notice. However, this Privacy Notice shall always prevail over the Privacy Notice For Members in relation to how we use your information for Samsung Members.

1. WHAT INFORMATION DO WE COLLECT?

A) We collect the following information, which you provide directly to us when you participate in the Contest or when you contact us through Instagram or Facebook:

- Samsung account information, such as your Samsung account ID, nickname, and password, if you participate in the Contest through Samsung Members App;
- Facebook profile name if you participate in the Contest through Facebook; and
- Information about you, as part of the comment you submit to us through Facebook Profiles.

B) If you are selected as a winner, the following personal data will also be collected from you:

- Your name;
- If necessary, information about you such as your e-mail address and/or phone number, or other information required to send you the prize; and
- If required under the applicable national legislation (such as tax laws, accounting laws), your personal identification number.

2. HOW DO WE USE YOUR INFORMATION?

We will use the information we collect for the following purposes:

- A) To conduct the Contest and pick a winner for it; and
- B) To administrate the prize to the winners of the Contest, in accordance with applicable legislation (including book keeping legislation, tax legislation or similar).

Samsung's legal basis to process the personal data in A) above is that it is necessary for Samsung's legitimate interests to process the personal data that may be submitted to Samsung in connection with the Contest. Samsung's legitimate interest is to arrange a competition which will entertain visitors of the Facebook Profiles and Samsung Members App and spread awareness of Samsung's products and brand.

Samsung's legal basis to process the personal data in B) above is that it is necessary for the entering into and performance of a contract between you and Samsung in relation to the administration of the prize. Samsung may also process the personal data based on the legal basis that it is necessary for Samsung to comply with legal requirements (for example, to comply with applicable accounting rules, tax laws, and to make mandatory disclosures to law enforcement and/or in connection with judicial procedures).

3. WHO DO WE SHARE YOUR INFORMATION WITH?

We may disclose your information internally within our business to the relevant teams such as, without limitation, the marketing team, customer services team, legal team, and the finance team. We may also disclose your information to the following entities, only to the extent that this will be necessary to conduct the Contest:

- **Affiliates.** Your information may be shared among Samsung affiliates for the purposes described in this Privacy Notice. The term 'affiliates' refers to companies related to Samsung Electronics Co., Ltd. by common ownership or control. Our affiliates include companies with the Samsung Electronics name. Affiliates may also include other companies related by common ownership or control, such as Samsung SDS Co., Ltd. Particularly, Samsung SDS Co., Ltd. operates and maintains, on behalf of Samsung Electronics Co., Ltd., a number of services.
- **Service Providers.** We may disclose your information to carefully selected companies that provide services for or on behalf of us, such as companies that help us with repairs, customer contact centres, customer care activities, advertising, conducting customer satisfaction surveys, billing, or that send emails on our behalf. These entities are limited by contractual provisions in their ability to use your information for purposes other than providing services for us.
- **Other Parties When Required by Law or as Necessary to Protect Our services.** There may be instances when we disclose your information to other parties:
 - To comply with the law or respond to compulsory legal process (such as a search warrant or other court order);
 - To verify or enforce compliance with the policies governing the conduct of the Contest; and
 - To protect the rights, property, or safety of Samsung, or any of our respective affiliates, business partners, or customers.

4. HOW LONG DO WE KEEP YOUR INFORMATION

You can delete your entry to the Contest (i.e. your comment on the Facebook Profiles) at any time you like. As the main rule, we will not delete any comments.

If you win the Contest, we will only process your personal data for the time necessary to make sure that you receive your prize, or in accordance with how long we have to store it for legal reasons. We will delete the personal data shortly after you have received your prize, if you are the winner, unless we are required to store your personal data for longer time as required from time to time by mandatory laws.

We will not keep your personal data for longer than is necessary for the purpose it was collected. This means that data will be destroyed or erased from our systems when it is no longer required.

We take appropriate steps to ensure that we process and retain information about you based on the following logic:

1. At least the duration for which the information is used to arrange the Contest;
2. As required under law, a contract, or with regard to our statutory obligations; or
3. Only for as long as is necessary for the purpose for which it was collected, is processed, or longer if required under any contract, by applicable law, or for statistical purposes, subject to appropriate safeguards.

5. WHERE DOES YOUR INFORMATION GO?

Please note that we do not have any influence over Instagram/Facebook and how personal data is processed by them. For more information on this, please see their respective privacy policies.

Your participation in the Contest will involve the transfer, storage, and processing of your personal information to other countries; such countries include, without limitation, countries in the European Economic Area, the United States of America, China, Singapore, Vietnam, India, Canada, the Philippines, and Japan. All international data transfers are subject to legal requirements to ensure that your personal information is processed safely and as you would expect.

We will take appropriate measures, in compliance with applicable law, to ensure that your personal information remains protected. Such measures include the use of Standard Contractual Clauses to safeguard the transfer of data outside of the EEA. 6. YOUR RIGHTS

You have the right to request details about the information we collect about you and to request us to correct inaccuracies in that information, to object to or request the restriction of processing, and to request access to, or the erasure or portability of your information. Under the laws of some jurisdictions, we may decline to process requests that are unreasonably repetitive, require disproportionate technical effort, jeopardise the privacy of others, are extremely impractical, or for which access is not otherwise required by local law.

If you request deletion of personal information, you acknowledge that you may not be able to fully participate in the Contest and that residual personal information may continue to reside in Samsung's records and archives for some time, in compliance with applicable law, but Samsung will not use that information for commercial purposes. You understand that, despite your request for deletion, Samsung reserves the right to keep your personal information, or a relevant part of it, in line with the above section on "How long do we keep your information?" and applicable laws. Samsung may suspend, limit, or terminate your access to the website for violating the Samsung Terms of Use when necessary to protect the rights, property, or safety of Samsung, or any of our respective affiliates, business partners, employees, or customers.
