

## Samsung Home Appliances "Instant and Grand Lucky Draw" Contest Terms and Conditions

1	<p>Samsung Home Appliances "Instant and Grand Lucky Draw" Contest ("Contest") is organised by Samsung Asia Pte. Ltd. ("Samsung") and is open to participants who are residents of Singapore and (i) aged 18 years and above as stated on their Identity Card/ Passport (as of <b>1 November 2017</b>); or (ii) aged 13 years and above as stated on their Identity Card/ Passport (as of <b>1 November 2017</b>), <b>AND</b> accompanied by parents/ guardians, and (iii) who have purchase any single product of Washing Machines, Robot Vacuum Cleaners, Refrigerators, Microwave Ovens and Air Conditioners ("Samsung Home Appliances") worth minimum of S\$899 in a single receipt from Samsung authorized dealers in Singapore.</p>
