

## **Terms and Conditions: Samsung Jet™ 90 and Samsung Clean Station™ Prize Draw**

By entering the Prize Draw described below (a “**Prize Draw**”) you (the “**Participant**”) agree to be bound by these terms and conditions (the “**Terms and Conditions**”).

1. **Promoter:** Samsung Electronics (UK) Limited, Samsung House, 1000 Hillswood Drive, Chertsey KT16 0PS.
2. The Prize Draw is open to UK residents aged 16+ with a valid and public Twitter account.
3. Employees or agents of the Promoter or anyone professionally connected to the Prize Draw are not eligible to enter.
4. No purchase is necessary to enter.
5. The Prize Draw will open at 9:00am (GMT) on 17 August 2020 and close at 23:59 (GMT) on 6 September 2020 (“**Prize Draw**”).

12. The winner will have two (2) days from the date of notification to claim their Prize by responding to the notification with a UK address for delivery. Prizes will be delivered within thirty (30) days to the address provided.
13. In the event the winner is unreachable, ineligible, or fails to claim the Prize in the time required, the winner shall forfeit their Prize and it will be awarded to a substitute winner, selected in accordance with these Terms and Conditions.
14. Samsung excludes liability, to the fullest extent permitted by law for any loss or damage arising from or in connection with the Prize Draw or with the acceptance or possession of any Prize.
15. All Prizes are subject to current tax laws, and may be considered to be a taxable benefit to those who have Participated and won. The Promoter will bear and pay directly to HM Revenue & Customs under the Samsung Tax Award Scheme the prevailing National Insurance Class 1A contribution rate (currently 13.8%) and the prevailing Basic rate of Income Tax (currently 20%) on all the Prizes awarded under these Terms and Conditions.
