2. The Promotion will commence at 00:01 (GMT) on 18 December 2017 and shall close at 23:59 (GMT) on 31 March 2018 (the "Purchase Period").

#### Eligibility

3. To be eligible to participate in the Promotion you must be a UK or ROI resident aged 18+ (a "Participant").
4. This Promotion is only available to consumers (i.e. not to any business or reseller).
5. Participants must hold a valid debit or credit card in order to activate the Reward.
