

## PROMOTION TERMS & CONDITIONS

Samsung Store Black Friday (“**Promotion**”). The promoter of the Promotion is Samsung Electronics South Africa (Proprietary) Limited, Registration number: 1994/003872/07 and/or its agencies (“**Organizer**”).

2. **Promotion Period:**
